ASSISTANT TEACHER (NURSERY), POST CODE-88/17 IN DIRECTORATE OF EDUCATION

The candidature of the following candidates were kept pending for want of deficient / requisite documents in the e-dossier. They were recalled by giving 1st opportunity w.e.f. 10.06.2021 to 19.06.2021 vide notice dated 08.06.2021 and 2nd and final opportunity w.e.f. 23.06.2021 to 27.06.2021 vide notice no. 22.06.2021. However, these candidates failed to upload the deficient /requisite documents in the e-dossier.
