- The DSSSB vide its advertisement No. 01/22 had advertised total 575 vacancies (UR-270, EWS-77, OBC-116, SC-85 & ST-27 including PwD- 23 & Ex-SM- 04), read with Notice No. 955 dated 13.03.2023, No. 1095-96 dated 03.04.2023 & No. 1098 dated 03.04.2023 vide which the vacancies have been revised as Total- 477 vacancies (UR-207, EWS-54, OBC-115, SC-75 & ST-26 including PwD- 19 & Ex-SM- 04) for the posts of Junior Engineer (Civil)/Section Officer (Civil) under Post Code- 801/22 in under combined examination scheme in different departments viz. MCD, DAMB, DUSIB, DTL, DSIIDC, I&FC & DTC.
- 2. The Tier-I examination (online mode) was conducted on **27.06.2022**, **28.06.2022** & **29.06.2022**.
- 3. The normalized marks obtained by **24924 candidates** who have duly appeared in Tier-I examination (Online mode) have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on **www.dsssbonline.nic.in**
- 4. Based on the performance in the Tier-I written examination (online Mode), a total of 4284 candidates who obtained marks above or equal to cut-off marks in their respective categories, as detailed below, have been provisionally shortlisted to appear in Tier-II examination, subject to the information furnished by the candidates in their online application forms. The shortlisted candidates shall be called for Tier-II examination separately.

Further, since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates shortlisted for appearing in Tier-II Examination does not entitle them any right over the post.
- Reserved Category candidates who have obtained marks above or equal to the last shortlisted UR Candidates have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR

Category, subject to availability of vacancies, otherwise for selection in their respective category.

- As per the Board Policy the minimum qualifying marks in One Tier & Two Tier examination for UR & EWS Category Candidate is 40%, for OBC candidate is 35% and for SC, ST, PH & ExSM candidate is 30%.
- 8. The details of Tier-II examination shall be notified separately by the Board. The candidates are advised to check the Board's website regularly.
- The above short-listing for Tier-II Exam for the posts of Junior Engineer (Civil)/Section Officer (Civil) for Post Code- 801/22 under combined examination scheme in different departments viz. MCD, DAMB, DUSIB, DTL, DSIIDC, I&FC & DTC will be subject to outcome of pending court case O.A No. 1673/2022 and other court cases, if any.
