**ORDER**

**WHEREAS**, The Hon'ble Central Administrative Tribunal, Principal Bench, New Delhi, vide order dated 03.12.2025 in OA No. 3806/2025 titled *Vikas Kushwah vs. Govt. of Delhi & Ors.*, has directed as under:-

"4. In view of the prayer made by the learned counsel for the applicant, the competent authority amongst the respondent is hereby directed to dispose of the aforesaid representation of the applicant, by passing a reasoned and speaking order, within a period of thirty days from the date of receipt of a certified copy of this order. A copy of speaking order so passed be given to the applicant. It is made clear that if the order is passed in favour of the applicant, consequential relief, if any, also be accorded to the applicant within a period of 45 thereafter.

5. The OA is disposed of in the aforesaid terms, without going into the merits, at the admission stage itself. Pending MAs, if any, shall also stand disposed of accordingly.

6. No order as to costs."

**WHEREAS**, As per requisition received from the Department of Health and family Welfare, GNCTD, the DSSSB vide its Advertisement No. 04/2024, had advertised posts of Nursing Officer under Post code 02/24. The Vacancies position is as under:-

**AND WHEREAS**, The examination for Post Code 02/24 was conducted on different dates viz. **12.08.2024 to 14.08.2024, 16.08.2024, 05.09.2024, 06.09.2024, 06.10.2024 and 24.10.2024**. The marks of all candidates were uploaded on the Board's website vide Notice No.79 dated 26.03.2025. The main result was declared vide Result Notice No.80 dated 02.05.2025.

**AND WHEREAS**, The applicant, **Sh. Vikas Kushwaha (Roll No.240021201025472)**, applied under the **OBC** category for the post of Nursing Officer under post code 02/24. He uploaded the BOC certificate issued by the Govt. of Rajasthan for applying for appointment to posts under the Government of India. He appeared in the examination, and secured **110.07 marks**. He was shortlisted for uploading of e-dossiers vide notice No.79 dated 06.03.2025 in UR category.

**AND WHEREAS**, the marks obtained above or equal to cut off marks in their respective categories had been provisionally shortlisted only to uploading requisite documents in e-dossier through OARS module, as detailed below:-

**AND WHEREAS**, The result was declared vide Result Notice No.80 dated 02.05.2025 and the category wise marks secured by the last provisionally nominated candidates are as under:-

**AND WHEREAS**, As per advertisement No. 04/2024, in accordance with Para 6 (Point IV & V) of the said advertisement, the following provisions are applicable:-

**“(iv) Only OBC (Delhi) candidates notified by the Government of NCT of Delhi vide letter/order No. F.19(10)/2001/S-III/Pt.File/2278-2285 dated 27/07/2007 (Annexure-III) and No. F.19(01)/2012/S.IV/1241-1258 dated 28/07/2016 (Annexure-IV) will be given the benefit of reservation/age relaxation under the OBC category. This has further been clarified by the Services Department, Government of NCT of Delhi vide Office Memorandum No. F.19(02)/2011/S.IV/Vol.I/856 dated 31/05/2021 (Annexure-V). OBC (Outside Delhi) candidates will be treated as Unreserved (UR) candidates and they must apply under the UR category. The OBC candidates must be in possession of a non-creamy layer certificate along with their caste certificate on or before the cut-off date.**

**(v) Only the following two types of certificates will be accepted as valid certificates for granting the benefit of reservation to OBCs:**

**(A) OBC certificate (Delhi) issued by the Revenue Department of GNCT of Delhi, on the basis of an old certificate issued to any member of the individual’s family by GNCT of Delhi.**

**(B) OBC certificate issued by a Competent Authority outside Delhi to a person belonging to a community duly notified as OBC by GNCT of Delhi. This certificate must mandatorily have been issued on the basis of an OBC certificate issued by the Government of NCT of Delhi to a family member of the concerned person who had been residing in Delhi before 08/09/1993.”**



**AND WHEREAS,** the candidate Sh. Vikas Kushwaha applied under OBC category and he is not in possession of OBC certificate as per advertisement. The said certificate issued by the Govt. of Rajasthan for applying for appointment to posts under the Government of India. Hence, he is considered as OBC (Outsider) and as per the orders/notification dated 27.07.2007, 28.07.2016 and 31.05.2021 issued by the Services Department, Govt. of NCT of Delhi as mentioned in previous para, is to be considered as an UR candidate.

**AND WHEREAS,** The marks of the last nominated candidate in post code 02/24 in UR Category were 116.44 and the marks obtained by the applicant Sh. Vikas Kushwaha were 110.07 which were less than the marks of last nominated candidate. Hence he was not nominated for the post in post code 02/24.

**AND WHEREAS,** the provisions of the advertisement No.04/2024 and the benefits of the provisions of the above mentioned orders of the Govt. of NCT of Delhi are applicable to all the candidates without any arbitrariness, discrimination or violation of constitutional guarantees.

**NOW THEREFORE,** The candidature of Sh. Vikas Kushwaha (DOB: 09.03.1996) cannot be considered for the Post of Nursing Officer in post code 02/24.

This issues with the prior approval of the Competent Authority and in compliance with the directions of Hon'ble C.A.T. vide Order dated 03.12.2025 in OA No. No. 3806/2025.
