**Sub: Release of Tier-I marks and shortlisting of candidates for Tier-II Exam
for the Post of Inspecting Officer under Post Code 46/24 in Labour
Department.**

1. The DSSSB vide its vacancy notice/Advertisement No. 05/24 dated 05/03/2024 with closing date 17/04/2024 had advertised **Total - 05 [OBC-03, SC-01, ST-01 including PwBD Cat (b)-01 & ExSM-01]** for the post of **Inspecting Officer under Post Code 46/24 in Labour Department**.
2. The Tier-I(Technical) CBT for recruitment in respect of this post was conducted on 08/07/2025.
3. As per corrigendum dated 08/07/2025 of Examination Scheme para 4, in Two Tier Technical Examination, the mandatory minimum qualifying marks will be applicable in domain subject specific i.e. Section-B and there will not be any minimum qualifying marks in Section-A. However, combined marks of both Section-A and Section-B will be reckoned for shortlisting of candidates for Tier-II Examination.
4. The Prorated marks obtained by 174 candidates who appeared in written examination have been uploaded on Board's website. Candidates can view their marks by logging in to their account in OARS module on www.dssbonline.nic.in.
5. Based on the performance in CBT Tier-I(MCQ) for 200 marks, the candidates who have secured equal or more marks in their respective category as per the details given below in the table have been provisionally shortlisted for Tier-II subject to correctness of the information furnished by the candidates in their online application forms

6. As per the Examination Scheme, short listing is being made on the basis of marks obtained in online Tier-I examination (Objective-MCQ) for 200 marks. The shortlisted candidates shall be called for Tier-II Exam separately.
7. Only those candidates have been considered in OBC Category who has declared that they are OBC (Delhi) in their online application form.
8. Since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates qualifying for appearing in Tier-II does not entitled them any right over the post.
9. The above shortlisted candidates for Tier-II for the post code mentioned above will be subject to outcome of pending court cases, if any.

10. While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any later stage.
