**SUPPLEMENTARY RESULT NOTICE NO.: 1582  
PGT (ENGLISH)-MALE  
IN DIRECTORATE OF EDUCATION, GNCTD  
UNDER POST CODE 132/2012**


1. The Delhi Subordinate Services Selection Board (DSSSB), on the requisition of Directorate of Education, GNCTD, had issued advertisement No. 02/12 with closing date 15.06.2012 inviting applications for filling 43 Vacancies (UR-23, OBC-13, SC-07, including OH-01) under Post Code 132/2012 for the post of PGT (English)-Male.
2. Sh. Rahul Singh Rathore (DOB: 04.12.1976) applied for the post of PGT (English-Male) under Post Code 132/2012 under UR Category and was assigned Roll No. 33000216. He scored 136.5 marks and was kept as Waitlist-01 UR candidate.
3. The results for the above post code were declared vide Result Notice No. 447 dated 17.10.2016, Notice No. 524 dated 27.06.2017 and Notice No. 543 dated 20.09.2017. A candidate Sh. Vikas Antil who secured 152.5 marks was selected vide result notice dated 20.09.2017.
4. After expiry of the validity of waitlist panel, the user department vide letter dated 24.11.2017 returned the dossier of the provisionally selected candidate namely Sh. Vikas Antil with the remarks that candidate did not fulfil the requirements of RRs as he did B.Ed in the year 2016 i.e. after the cut-off date.
5. DSSSB informed the user department vide letter dated 28.05.2018 that as per Board Policy waitlist panel is valid for 01 year from the date of declaration of result. The waitlist panel was valid upto 16.10.2017, as such the Board is not able to nominate any further candidate against the cancelled candidature of Sh. Vikas Antil.
6. Sh. Rahul Singh Rathore filed OA No. 3183 of 2018 seeking appointment to the Post of PGT (English) Male under Post Code 132/12 with consequential reliefs. The Hon'ble CAT vide order dated 03.02.2023 allowed the OA with the following directions:-

*"21. For the reasons stated and dealt with exhaustively hereinabove, the O.A. is allowed. The impugned order dated 20.09.2017 is quashed and set aside. DSSSB is directed to forward the dossier of the applicant to the user department within one month from the date of receipt of this order,*



*who may verify the same and if found suitable and eligible after verification of such credentials, he may be offered appointment within two month thereafter. The applicant shall not be entitled to any consequential benefits except notional seniority and notional fixation of pay as per law. No costs."*

7. Against above order dated 03.02.2023 of Hon'ble CAT, a writ Petition was filed in Hon'ble High Court of Delhi vide No. W.P.(C) No. 8708/2023. But the same was dismissed by the Hon'ble High Court vide Order dated 28.08.2025. The Department of Law, Justice & Legislative Affairs, Govt. of NCT of Delhi opined that there does not appear to be any infirmity in the Order dated 28.08.2025 passed by the Hon'ble High Court of Delhi.
8. **Accordingly, in compliance with the Order dated 03.02.2023 of Hon'ble Tribunal in O.A. No. 3183/2018, upheld by the Hon'ble Delhi High Court vide Order dated 28.08.2025 in W.P.(C) No. 8708/2023 and the Legal Opinion of the Law Department, GNCTD, Sh. Rahul Singh Rathore (DOB: 04.12.1976, Roll No. 33000216) is hereby provisionally nominated, under UR Category, for the post of PGT (English)-Male under the post Code 132/2012 in Directorate of Education, GNCTD, subject to fulfilling all others conditions of eligibility and also correctness of information furnished by the candidate in his application form and dossier.**
9. As per the Board's resolution dated 14/07/2022 and as per decision of the Board dated 20/01/2023, no scrutiny of documents in the dossier and of the other terms and conditions of recruitment notified by the Board in the advertisement of the said post code has been done by the Board. The eligibility as per Recruitment Rules and other terms and conditions as specified in the Advt. No. 02/2012 & its corrigendum/ addendum etc. (if any) and relaxation as per rules in respect of educational qualifications, experience, other certificates shall be scrutinized/verified by the User Department for determining eligibility of the candidate for the Post Code 132/2012 before issuance of offer of appointment of the post.
10. The provisional nomination of the above 01 candidate (UR-01) shall be further subject to thorough verification of the candidature of the candidate by the User Department including the identity of the candidate.
11. The provisional nomination of the above 01 candidate (UR-01) shall further be subject to genuineness of the documents on the basis of which he has claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of his identity with reference to his photograph,





- signature/ handwriting, etc. on the application form, admission certificate, etc. The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after being satisfied about her eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
12. The User Department i.e. Directorate of Education, GNCTD shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to take decision to rectify/ correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
  13. It is stated that the User Department shall verify the genuineness of the caste certificate (if any) furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidate is fulfilling the necessary criteria as prescribed for entitlement of caste certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
  14. The User Department shall also get the SC/ST/OBC/EWS certificates verified from the issuing authority before her appointment. Further, in case of OBC Candidate, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/ 2004-Estt. (Res) dated 09/03/2004 and OM No.36033/3/2004-Estt.(Res) dated 14/10/2008 OM No. 36033/I/2013-Estt. (Res) dated 27/05/2013 & 13.05.2017 OM No. 36039/1/2019-Estt. (Res) dated 31/01/2019.
  15. The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after being satisfied about his eligibility as laid down in the recruitment Rules and after



verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.

16. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
17. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
18. The recruitment process for the Post of PGT (English)-Male under the post Code 132/2012 in Directorate of Education, GNCTD has already been closed. Further, the Wait List panel of the candidates has already been expired.
19. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
20. The nomination of the candidate is subject to outcome of Court-case/review petition filed in the matter, if any. Further, the User Department shall also ensure that subsequent appointment and any other action will be subject to outcome of Court-case/review petition filed in the matter at any stage.
21. This issues with the prior approval of Hon'ble Chairman, DSSSB.
