Subject : Releasing of marks (Tier-I) and shortlisting of candidates for (Tier-II) Examination.

1. The DSSSB vide its advertisement No. 01/21 read with revised advertised vacancies vide notice dated 23.06.2025 **total – 50 vacancies including PwBD-03 i.e. HH-01 & OH-02 (UR-12, EWS-13, OBC-14, SC-07 & ST-04)** for the post of **Junior Engineer, Electrical & Mechanical under Post Code- 15/21** in Delhi Jal Board(DJB).
2. The written examination (online mode) TIER-I were conducted on 21.03.2022.
3. The normalized marks obtained by **4483 candidates** who have duly appeared in written examination held on 21.03.2022 has been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on www.dsssbonline.nic.in
4. Based on the performance in the Tier-I written examination (online Mode), a total of **586 candidates (including two bracketed candidates) who obtained marks above or equal to cut-off marks in their respective categories, as detailed below, have been provisionally shortlisted to appear in Tier-II examination**, subject to the information furnished by the candidates in their online application forms. The shortlisted candidates shall be called for Tier-II examination separately.



*the post is exclusively advertised for PwBD sub-category (b) & (c) i.e. HH & OH respectively only.

5. Reserved Category candidates who have obtained marks above or equal to the last shortlisted UR Candidates have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR Category, otherwise for selection in their respective category, subject to availability of vacancies,,
6. Candidate bearing roll No. 121101503191 could not be shortlisted due to overage in UR.

7. Further, since documents have not been called from the candidates along with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of names in the list of candidates shortlisted for appearing in Tier-II Examination does not entitle them any right over the post.
8. As per the Board Policy the minimum qualifying marks in the examination for UR & EWS Category Candidate is 40%, for OBC candidate is 35% and for SC, ST & PwBD candidate is 30%.
9. **The details of Tier-II examination shall be notified separately by the Board. The candidates are advised to check the Board's website regularly.**
10. The above short-listing for Tier-II Exam for the post of **Junior Engineer (Electrical & Mechanical) under Post Code- 15/21 in Delhi Jal Board (DJB)** will be subject to outcome of pending court cases, if any.
11. While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
