TEACHER (PRIMARY) UNDER POST CODE 16/08 IN MUNICIPAL CORPORATION OF DELHI

- 1. Ms. Nirmala (Roll No. 01624050) applied for the Teacher (Primary) under Post Code 16/08 and is in zone of consideration.
- 2. The Main result for the said post was declared vide Result Notice No. 46 dated 06.10.2009. The judgment dated 04.08.2009 of Hon'ble Supreme court of India as passed in court case Civil Appeal No.5092 of 2009 arising out of petition (s) for special Leave to Appeal (civil) No(s). 24327/05 Subhash Chandra & Ors V/s DSSSB & Ors. Therefore, the candidature of Ms. Nirmala (Roll No. 01624050) could not be considered under ST category.
- 3. Ms. Nirmala filed OA No. 4111/2013 titled as Nirmala Vs GNCTD & Ors. and DSSSB filed WP(C) No.7846/2018 titled as GNCTD & Ors. Vs Nirmala before the Hon'ble High Court of Delhi. In compliance of orders of Hon'ble Courts, a Notice No. 1483 dated 31/05/2024 was issued for calling of dossier of the candidate and Ms. Nirmala submitted her dossier/documents.
- 4. In compliance of directions of Hon'ble High Court & Hon'ble Tribunal in the abovementioned matters and on the basis of marks obtained in written Examination, the candidate having following roll no. is hereby provisionally nominated for the post of Teacher (Primary) under Post Code 16/08 in MCD, subject to fulfilling all conditions of eligibility and correctness of the information furnished by the candidates in her application form and the dossier/documents:-

- As per the Board's resolution dated 14/07/2022 and as per decision of the Board dated 20/01/2023, the Board has not undertaken scrutiny of documents as provided by candidate and other terms and conditions of recruitment notified by the Board in the advertisement of the said post code at this stage. The eligibility as per Recruitment Rules and other terms and conditions as specified in the Advertisement No. 02/2008 and relaxations as per rules in respect of educational qualifications, experience, etc. shall be scrutinized/verified by the User Department for determining eligibility of the candidate for the post code 16/08 as on cutoff date, before issuance of offer of appointment to the post.
- 6. The User Department i.e. Municipal Corporation of Delhi is requested to undertake veracity/scrutiny of documents as per Recruitment Rules for the Post and on being satisfied that the applicant possesses the requisite qualification.
- 7. The selection of the above-mentioned 01 candidate shall be subject to genuineness of the documents on the basis of which she has claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of her identity with reference to her photograph, signature/handwriting, etc. on the application form, admission certificate, etc.
- 8. The Candidature of the above candidate is liable to be cancelled by the user department also, in case the candidate is found not to be fulfilling the terms and conditions of the advertisement inviting application for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after being satisfied about her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
- 9. The User Department shall also get the SC/ST/OBC/EWS/PH certificates verified from the issuing authority before his /her appointment. Further, in case of OBC Candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No. 36033/3/2004-Estt. (Res) dated 14/10/2008 and OM No. 36033/I/2013-Estt. (Res) dated 27/05/2013 and 13/09/2017 and other instructions/guidelines issued from time to time by the competent authorities.
- 10. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.



- 11. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
- 12. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any.
- 13. The result is subject to the outcome of the court cases, if any, pending in various courts related to this post.
- 14. This issues with the prior approval of the Chairman, DSSSB being Competent Authority.
