1	5110000003	The candidate has not uploaded two years unblemished experience in the line, hence, 1 <sup>st</sup> opportunity w.e.f. 24.03.2021 to 02.04.2021 is being given to upload the two years unblemished experience in the line as on cutoff date i.e. 15.06.2012, in the e-dossier.
2	5110000001	The candidate has uploaded two years experience in the line w.e.f. 10.01.2014 to 01.02.2017 which is after cutoff date. Hence, the candidate is being given 1 <sup>st</sup> opportunity w.e.f. 24.03.2021 to 02.04.2021 to upload two years experience as on cutoff date ie.15.06.2012, in the e-dossier.

- 3. The e-dossier link shall be activated for a period of 10 days w.e.f. 24.03.2021 to 02.04.2021.
- 4. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria as on the cutoff date, i.e **15.06.2012** as per Advertisement No. 02/12.
