SUPPLEMENTARY RESULT NOTICE NO. 779 DATED 01.04.2021

TGT (HINDI) FEMALE, POST CODE-141/17 IN DIRECTORATE OF EDUCATION.

The DSSSB vide its advertisement No. 04/2017 dated 22/12/2017 had advertised total 151 [UR-93, OBC-14, SC-26, ST-18, including PH (OH-03, VH-02)] vacancies for the post of TGT (Hindi) Female, Post Code-141/17 in Directorate of Education with closing date as 31.01.2018. Tier-I examination in online computer based examination mode was conducted on 28/08/2018 & 15/09/2018.

- On the basis of online examination of Tier-1 held on 28/08/2018 & 15/09/2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of TGT (Hindi) Female, Post Code-141/17 in Directorate of Education, a total of 148 candidates (UR-93, OBC-11, SC-26, ST-18 including PH/OH-03, VH-02) candidates were provisionally nominated for the post of TGT (Hindi) Female, Post Code-141/17 vide Result Notice No. 436 dated 22.05.2019 and 03 candidates were provisionally nominated vide Supplementary Result Notice No. 491 dated 05.08.2019. Further, the User Department vide letter dated 27/12/2019 & 02/03/2020 had returned the dossiers of 19 candidates (UR-10, SC-05, ST-02, PH/OH-02) after cancellation of their candidature due to not accepting of offer of appointment. Accordingly, 19 vacancies (UR-10, SC-05, ST-02, PH/OH-02) had been vacant & 04 vacancies had also been created under OBC category due to shifting of 04 candidates from OBC category to UR category as per their merit. Therefore, 23 candidates (UR-12 inc. 01 PH, OBC-04, SC-5, ST-02) were provisionally nominated vide Supplementary Result Notice No. 654 dated 17/08/2020.
- Furthermore, the User Department vide letter dated 24.06.2020 & 02.07.2020 had returned 12 dossiers (UR-09 inc 01 PH, OBC-01, SC-02) of the candidates after cancellation of their candidature due to not joining at place of posting. As, these dossiers were received after expiry of waiting panel, no substitute candidate could be provided, however, the waiting panel now been extended upto 31.12.2020, the candidates from waiting panel have been considered against the dossiers received on 24.06.2020 & 02.07.2020 .
- (i) Accordingly, in continuation to Result Notice No. 436 dated 22.05.2019 & 4. Supplementary Result Notice No. 491 dated 05.08.2019 & Supplementary Result Notice 654 dated 17/08/2020, the candidates, as detailed below, are also provisionally selected on the basis of online examination of Tier-1 held on 28/08/2018 & 15/09/2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of TGT (Hindi) Female, Post Code-141/17 in Directorate of Education.

- 5. * The candidates bearing Roll No. 110614100654, 120114104242, under UR category above were earlier nominated under OBC category vide Result Notice no. 436 dated 22/05/2019 & 491 dated 05.08.2019 respectively as per their merit. Now, these candidates have been shifted under UR category as the merit of UR category became lower and the candidature of these candidates are coming in zone of consideration under UR category as per their merit. The user department is, therefore, requested to modify the result/record of these candidates by shifting from OBC category to UR category.
- 6. The selection of the above candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Directorate of Education shall verify the genuineness of the Caste Certificates furnished by the candidates prior to issuing offer of appointment to the candidates. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.

- 8. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 9. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.
- 10. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.
- 11. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.
- 12. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the User department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- 13. The marks obtained by the last provisionally nominated candidate are as follows:

Note:- In advertisement no. 04/17, in para-2 (vii) - Mode of Selection (Examination Scheme), it has been mentioned that "If there are two or more candidates in the same category having equal marks in the examination, the candidate older in age will get preference. In case of further tie, candidate having higher marks in Section "A" of the test shall be preferred".

- 14. The recruitment process for the post of TGT (Hindi) female, Post Code-141/17 stands closed in all respect.
- 15. A waiting panel was prepared which has been expired on 21.05.2020 as per earlier result notice no. 436 dated 22.05.2019. However, the same has been extended upto 31.12.2020.
