### SUPPLEMENTARY RESULT NOTICE NO. 1095

## Assistant Teacher (Primary) In Directorate of Education, GNCTD Post Code 15/19

- The DSSSB vide its advertisement no. 03/2019 with closing date 15/10/2019 had advertised 637 vacancies {UR-332, OBC-119, SC-115, ST-35, EWS-36 including 13 PH (OH) and 14 PH (VH)} for the Post of Assistant Teacher Primary under post code 15/19 in Directorate of Education, GNCTD.
- 2. The written examination (online mode in three shift) Tier-I for recruitment in respect of this post was conducted on 11th, 13th, 14th and 15th November, 2019.
- 3. DSSSB vide Result Notice No. 1015 dated 24/07/2020 and No. 1033 dated 24/08/2020, 1088 dated 14/12/2020 has provisionally selected 616 candidates, 10 candidates and 10 candidates respectively for the post of Assistant Teacher Primary under **post code 15/19** in Directorate of Education, GNCTD.
- 4. Section officer, E-IV, DR Cell, Directorate of Education, GNCT of Delhi letter No. F.No.DE.4(16)/DRC/E-IV/PRT(15/19)/2020/7555 dated 09.12.2020 and letter No. F.No.DE.4(16)/DRC/E-IV/PRT(15/19)/2020/1563 dated 15.12.2020 sought clarification reg. category of the candidates nominated for the post of Assistant Teacher (Primary), Post Code-15/19 in respect of 11281101946, 11141102893, 11281101631, 12321112283 and 11201100874.
- 5. After scrutiny it has been noticed that candidate having Roll No. 11281101946 (DOB-04.06.1987) and Roll No. 11141102893 (DOB 16.07.1984) were earlier selected under UR category as per Result Notice No. 1015 dated 24.07.2020. Further for selection in UR category the upper age limit was 30 years, as on 15.10.2019 (cut off date), however in the above cases both the candidates have age of more than 30 years on cut off date. Inadvertently besides overage in the UR category, selection of candidates was done in the UR category according to their marks. Since these candidates availed age relaxation according to their original category accordingly, candidature of candidate having Roll No. 11281101946 is rescinded in UR category and shifted to her original category i.e. OBC, further candidature of candidate having Roll No. 11141102893 is rescinded in UR category and shifted to his original category i.e. PH(OH) as per their merit.
- After scrutiny, it has further noticed that candidate having Roll No 11281101631, 12321112283 and 11201100874 were earlier selected under UR category, as per Result

Notice No. 1015 dated 24.07.2020. Further, for selection in UR category candidate should have obtained more than 60% marks in CTET examination i.e. 90 or more out of 150, however in the above cases all three candidates obtained marks less than 90 out of 150 in the CTET examination and qualified in OBC category. Since these candidates obtained less marks than 90 out of 150, and availed relaxation according to their original category i.e. OBC category in qualifying in CTET examination accordingly, candidature of candidates having Roll No. 11281101631, 12321112283 and 11201100874 are hereby rescinded in UR category and shifted to their original category i.e. OBC as per their merit.

7. Consequent upon shifting of candidature of candidates having Roll No. 11281101946, 11281101631, 12321112283 and 11201100874 from UR category to OBC and candidature of candidates having Roll No. 11141102893 from UR category to PH(OH) category, 05 vacancies in UR category created, accordingly candidature of following candidates are hereby provisionally nominated as per their merit, after preliminary scrutiny of the candidature of the candidate as per the provisions of the statutory Recruitment Rules and terms and conditions of the advertisement:-

Further candidature of 01 candidate having Roll No 11281100581 earlier selected in OBC category vide Result Notice dated 24.07.2020 now shifted to UR category as per merit.

- 8. Consequent upon shifting of candidature of 04 OBC category candidates having Roll No 11281101946, 11281101631, 12321112283 & 11201100874 who are earlier selected in UR category as per their merit to OBC category, 04 excess selection in OBC category has been made accordingly candidature of 03 candidates having Roll No 11181100079, 11171102278 & 11221102715 selected vide Result Notice dated 24.07.2020 and 14.12.2020 respectively are hereby rescinded. Further 01 candidate having Roll No 11281100581 earlier selected in OBC category vide Result Notice dated 24.07.2020 now shifted to UR category as per merit.
- 9. Consequent upon shifting of candidature of 01 PH(OH) category candidates having Roll No 11141102893 who earlier selected in UR category as per their merit to PH(OH) category candidature of 01 candidate of PH(OH) category having Roll No 11141100502 selected vide Result Notice dated 24.08.2020 is hereby rescinded.
- 10. Further candidature of 01 candidate having Roll No. 11221102578 in EWS Category was kept pending vide Supplementary Result Notice No. 1088 dated 14/12/2020. Now in view of additional documents furnished by the candidate whose candidature was kept pending for required documents, after preliminary scrutiny of the candidature of the candidate as per the provisions of the statutory Recruitment Rules and terms and

conditions of the advertisement, the following candidate is hereby provisionally nominated as per their merit:

- 11. The provisional selection of the above 05 candidate (UR-04 & EWS-01) shall be further subject to thorough verification of the candidature of the candidate by the User Department including ascertaining the identity of candidates.
- 12. The provisional selection of above 05 candidate (UR-04 & EWS-01) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied himself about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- 13. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
- 14. The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Directorate of Education, GNCTD shall verify the genuineness of the EWS and caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 15. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt.

(SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.

- 16. The User Department shall also get the SC/ST/OBC certificates verified from the issuing authority before his /her appointment. Further, in case of OBC Candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No. 36033/3/2004-Estt. (Res) dated 14/10/2008 and OM No. 36033/I/2013-Estt. (Res) dated 27/05/2013 & 13.05.2017.
- 17. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 18. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
- 19. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
- Further, the result is subject to the outcome of the court cases, if any, pending in various courts related to this post.
- 21. The category wise marks scored by the last candidate provisionally nominated are as under:-
