NOTICE 825 LIBRARIAN IN DIRECTORATE OF EDUCATION UNDER POST CODE 163/2007

- 1. The DSSSB vide its advertisement number 07/2007 with closing date 29.10.2007 had advertised 39 vacancies (UR-20, OBC-15, SC-03 & ST-01 including OH-01 and VH-01) for the post of Librarian in Directorate of Education under Post code 163/07 in the pay scale of Rs. 5500-9000/-(Prerevised). Board had conducted Part-I examination under old examination scheme for recruitment to this post on 18.01.2009.
- 2. The result for the postcode 163/07 was not declared earlier as it was initially informed by the Directorate of Education letter dated 13/03/2009 to keep in abeyance the anticipated vacancies for 2007-08 & 2008-09 till the appointment process for the selection of 87 posts (postcode 17/07) is completed. Since 39 vacancies were advertised under the post code 163/07, accordingly DSSSB did not process the result for post code 163/07. Later Directorate of Education had included the 39 vacancies in their subsequent requisitions.
- 3. The Ld. Central Administrative Tribunal vide order dated 21.07.2014 in O.A. No. 926/13 in the matter of Richa Gupta vs DSSSB & Anr had directed the DSSSB to finalize the selection process of postcode 163/07. DSSSB had filed appeal against the Ld. Tribunal order dated 21.7.2014 in Hon'ble High Court vide WP(C) No. 1504/2015 titled as DSSSB & Anr. Vs. Richa Gupta. During the hearing of the writ petition Directorate of Education stated before the Hon'ble High Court that 39 posts of Librarian advertised vide post code 163/07 can be adjusted by them against present vacancies, if DSSSB is in the position to declare the result. Accordingly Hon'ble High Court vide judgment dated 20th March 2017 in WP (C) No. 1504/2015, DSSSB & Anr. Vs. Richa Gupta dismissed the appeal. Further Hon'ble High Court vide judgement dated 21.03.2017 in the matter titled Ashok Kumar vs Chief Secretary, GNCT of Delhi and Ors. bearing WP(C) No. 1826/2016 also decided the petition in view its earlier order dated 20.3.2017. This order has attained finality.
- 4. Accordingly in pursuance of above referred judgments and Directorate of Education's letter no. DE.4/1/(340)/E-IV/Court Case/2012/10159-10160 dated 12.07.2016, No. DE.4/1/(340)/E-IV/Court Case/2012/2173 dated 09.06.2017 and No. DE.4/1/(340)/E-IV/Court Case/2012/4141 dated 24.10.2017, DSSSB has initiated the selection process for postcode 163/07.
- 5. The DSSSB vide Result Notice No. 711/CC-I dated 24.09.2018 had shortlisted 416 candidates for the post of Librarian in Directorate of Education under post code-163/07 for evaluation of their Part-II examination descriptive answer

- sheets. Board had conducted Part-II examination under old examination scheme for recruitment to this post on 18.01.2009.
- 6. The marks list of Part-II examination for the post of Librarian in Directorate of Education under post code-163/07 of 402 shortlisted candidates out of 416 shortlisted candidates had been declared vide notice number 741 dated 16.11.2018.
- 7. The result for the said post code was issued vide result notice no. 743 dated 05.12.2018 in which at para no. 7 it was informed that the result of 14 candidates having Roll Nos. 1710468, 1711104, 1711320, 1713029, 1713069, 1810014, 1810046, 1810080, 16310001, 16310008, 16310037, 16310038, 16310045 and 16310047 have not been declared as their Part-II examination answer sheet for post code 163/07 are not available/ traceable being old record and 16 vacancies were withheld for finalization of their claim which were called separately.
- 8. An advertisement in this regard was published in the leading newspapers on 01.12.2018 and letters were also sent on 30.11.2018 to the candidates whose addresses were available with the Board.
- 9. In response to the said notice, the candidates having Roll Nos. 1711104, 1713029, 1810046, 16310008, 16310037, 16310038, 16310045 and 16310047 have preferred their claim for the said post.
- 10. In the interest of natural justice, DSSSB intends to hold the Part-II examination of Post Code 163/07 for the candidates mentioned at Para No. 9 above who have preferred their claim and it is informed that since the Part-II exam is to be held only for those candidates whose answer sheets were not available/traceable, the normalization would apply as per the Board's Policy as notified vide Notice No. F.No. 10(271)/Sec.Cell/DSSSB/18/989, dated 11.07.2018. The part-II examination of Post Code 163/07 will be held as per the examination scheme published in the Advertisement No. 07/2007. The 08 candidates as mentioned in Para 9 above were requested to submit an undertaking to appear in re-examination to be conducted as per the schedule of the Board.
- 11. In response, candidates having Roll Nos. 1713029, 1810046, 16310008, 16310037, 16310038, 16310045 and 16310047 have submitted their undertaking to appear in re-examination to be conducted as per the schedule of the Board.
- 12. 01 candidate having Roll No. **1711104 has not given undertaking to** appear in re-examination.
- 13. Now, the Board has decided to conduct the Part-II re-examination of for the Post of Librarian under Post Code 163/07 of the following 08 candidates having Roll Nos. 1713029, 1810046, 16310008, 16310037, 16310038, 16310045, 16310047 and 1711104, in the old examination scheme for recruitment to this post as conducted earlier.

- 14. The details of the said Part-II re-examination shall be notified separately by the Board.
- 15. All the above mentioned candidates are therefore advised to regularly visit the Board's website www.dsssb.delhi.gov.in for further update regarding the schedule of exam.
