## ORDER

This order shall dispose of the representation/grievance dated 02.03.2021 filed by Ms. Manisha Kumari Meena (Roll No. 11161500861) candidate for the post of Assistant Teacher (Nursery), Post Code-16/19.

- 2. The candidate Ms. Manisha Kumari Meena (Roll No. 11161500861) applied for the post of Assistant Teacher (Nursery) under Post Code-16/19 under ST category and appeared in the computer based online examination on 19.11.2019 and scored 74.35 marks out of 200 marks. The Candidate was shortlisted for uploading of all the relevant documents in the e-dossier with regard to <a href="Educational/Professional Certificates/Degree and Mark sheets/Caste Certificate/Disability certificate/Proof of Govt. Servant/Ex. Servicemen/Admit Cards etc., as applicable in the E-dossier module in OARS link in his/her individual account in OARS module w.e.f. 30.06.2020 to 14.07.2020 (15 days) vide Notice No. F. No. 236/Result/Asstt. Teacher(Nursery)/Int. Cell/DSSSB/2019-20/1636-44 dated 22/06/2020 on the Board's website i.e. www.dsssb.delhi.gov.in.
- 3. That the candidate Ms. Manisha Kumari Meena (Roll No. 11161500861) did not upload the documents in the e-dossier within the given 15 days time period w.e.f. 30.06.2020 to 14.07.2020 and accordingly, her candidature was rejected vide **Rejection Notice No. 807 dated 16.08.2021.**
- 4. That the candidate Ms, Manisha Kumari Meena (Roll No. 11161500861) has submitted representation dated 02.03.2021 stating that due to lack of knowledge, she could not upload e-dossier within time and requested to give her one more opportunity.
- 5. As per policy of the Board, the candidates are given 15 days time period to upload the edossier in OARS module, failing which their candidature is cancelled and no further opportunity is given on whatsoever ground. The Board strictly adhere its policy with regard to uploading of e-dossier within the stipulated time period which has also been upheld by the Hon'ble High Court in W.P. (C) No. 4085/2019 in the matter of Ms. Jyoti Vs. GNCTD & Anr & W.P. (C) No. 2892/2019 in the matter of Pushpendra Singh Parnami Vs. DSSSB & Ors.
- 6. In view of the above, the representations dated 02.03.2021 in r/o of Ms. Manisha Kumari Meena (Roll No. 11161500861) has been considered and examined in detail and dismissed as the reason for rejection of her candidature for the post of Assistant Teacher
