Further for benefit of reservation to SC category candidates result has been processed as per judgment of Hon'ble High Court passed in WP(C) No. 5390/2010 titled Deepak Kumar Vs Distt. Session Judge, & letter dated 10.5.2013 issued by Spl, Secretary (Services) regarding reservation policy to be followed by with regard to SC/STs in the civil posts under GNCTD. The OBC category candidates with certificate of Delhi Origin issued by the Competent Authority of Govt. of NCT of Delhi only have been considered for admissibility of benefit of reservation.
