- The DSSSB vide its Advertisement No. 01/2015 with closing date 26/11/2015 had advertised 01 vacancy {UR(EXSM)-01} for the post of LDC (Male) reserved for Ex-Serviceman in Rajya Sainik Board under Post Code 58/15. Board Conducted Tier-I written examination for recruitment in respect of this post on 05/09/2019.
- 2. On qualifying Written Examination, vide Notice No. **860** dated **18/12/2019**, the DSSSB has shortlisted 03 candidates for appearing in Skill Test/Typing Test for the post of LDC(Male) under post code 58/15. The Skill Test was conducted on 24/12/2019 wherein out of 03 candidates, 02 candidates appeared for the test. In the Skill Test conducted, out of 02 candidates only 01 candidate could qualify.
- 3. As per RRs for the Post the candidate was to qualify the 30 w.p.m. in typewriting in English or 25 w.p.m. in typewriting in Hindi.
- 4. The roll numbers of the Skill Test Qualified Candidate is 4630000003.
- 5. Based on the performance in the written examination and being qualified in Skill Test, 01 candidate {UR (EXSM)-01} who has qualified the typewriting skill test as per details given below is being provisionally shortlisted and accordingly allowed to upload e-dossier subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application form.

- 6. The shortlisted candidate for the above-mentioned post/post code is hereby informed to fill the e-dossier and up-load all the documents of Educational Certificate/Professional/Experience Certificates/Degree and Marks sheets/Caste Certificate/Proof of Govt. Servant/Ex Servicemen/Admit Cards, etc., as applicable in the e-dossier module in OARS link in his account in OARS module. Shortlisting is being made on the basis of marks obtained in Tier-I examination (Objective-MCQ) for 200 marks and being also qualified in skill test.
- 7. Kindly note that the e-dossier link will be activated to only those candidates who are provisionally shortlisted to upload e-dossier as per details given in para 5 above.
- 8. All the candidates who have been shortlisted for falling in consideration zone of selection MUST upload their all requisite/applicable documents in the said link in stipulated time.

- 9. The e-dossier link shall be active from 10/08/2020 to 24/08/2020. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria/all essential qualifications as per RRs for the Post as on date of Closing date of application, i.e., 26/11/2015.
- 10. The above shortlisted candidate is also being separately informed through SMS and e-mail on his registered mobile number and e-mail ID as an additional facility. If the candidate fails to upload the e-dossier during the above said period, his candidature will be rejected and no further opportunity will be given on whatsoever ground.
- 11. The candidates who has been shortlisted for uploading e-dossiers MUST upload his all requisite/applicable documents in the said link in stipulated time i.e. 10/08/2020 to 24/08/2020.
- Mere asking the candidate for up-loading documents in the e-dossier module does not confer upon him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he/she will not be given any further opportunity and his candidature will be treated as cancelled.
- 13. The above shortlisting of candidate for calling of e-dossier for the post code -58/15 will be subject to outcome of pending court cases, if any.
