1. The DSSSB vide its advertisement number 02/2014 with closing date 25/01/2015, had advertised 47 vacancies (UR-42, OBC-03, SC-01, ST-01 including 01 HH ExSM-05 and SP-02) for the Post of Stenographer, Grade-III in Services Department under Post Code 211/14 which were further increased to 349 vacancies (UR-173, OBC-100, SC-36, ST-40 including VH-07, HH-01, OH-04, ExSM-42 and SP-02) vide addendum dated 07/06/2018. Board Conducted Tier I Written Examination for selection to the Post along with similar Post Codes on 11/06/2017. Board had declared marks of Tier I written examination of the Candidates of the Post of Stenographer, Grade-III in Services Department under Post 211/14 vide notice number 550 dated 06/10/2017.
2. Based on the performance in the One Tier Examination, 666 candidates were shortlisted for appearing in the Phase II of shorthand and typewriting skill test vide notice no. 708 dated 25/08/2018 and 751 dated 13/12/2018. The Skill test for shorthand and typewriting was conducted with effect from 04/01/2019 to 06/01/2019, wherein 489 candidates appeared and the result of qualified candidate in skill test held between 04.01.2019 to 06.01.2019 was declared vide notice no. 785 dated 20.05.2019.
3. The Board has adopted the criteria for evaluation of skill test and in the skill test considered up to 7% mistake for UR category and up to 10% mistake for all reserved category candidates, on the pattern of SSC, as qualified in the shorthand skill test with a speed of 80 w.p.m.
4. As per RRs for the Post the candidate was to qualify the 40 w.p.m. in typewriting in English or 35 w.p.m. in typewriting in Hindi.
5. DSSSB vide Result Notice No. 707 dated 25.08.2018, 749 dated 13.12.2018, 791 dated 17.06.2019, 807 dated 22.08.2019 and 960 dated 02.03.2020 have declared result of selected candidates for the post of Stenographer Grade-III in Services Department under post code 211/14.
6. Further candidature of 18 candidates having roll nos. 14302804, 14315855, 14310805, 14315812, 14307712, 14306698, 14314626, 14305227, 14301932, 14307625, 14301757, 14316656, 14302070, 14312339, 14311061, 14305335, 14316610 and 14308845 were kept pending vide Supplementary result notice no. 960 dated 02.03.2020. Now, in view of

additional documents furnished by these candidates, whose candidature was kept pending for required documents, after preliminary scrutiny of the candidature of the candidate as per the provisions of the Statutory Recruitment Rules and Terms & Conditions of the Advertisement, the following candidates are hereby provisionally nominated as per their merit.

The above pending 07 candidates (UR-07) are being given 2<sup>nd</sup> and final opportunity to upload their pending/all requisite/applicable documents through the e-dossier link on OARS module of the Board within stipulated time. The e-dossier link shall be active from 07.08.2020 to 11.08.2020, failing which their candidature will be rejected and no further opportunity will be given on whatsoever ground. The above candidates are also being separately informed through SMS on their registered mobile number.
9. The selection of the above 12 candidates (UR-08 and SC-04) shall be further subject to thorough verification of the candidature of the candidate by the User Department including the identity of the candidate.
10. The Selection of the above 12 candidates (UR-08 and SC-04) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
11. The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Services Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
12. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education

qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.

13. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
14. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
15. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
16. The result is subject to the outcome of the court cases, if any, pending in various courts related to this post.
17. The category wise marks scored by the last candidate provisionally nominated are as under:-
