1. The DSSSB vide its advertisement no. 02/2019 with closing date 05/03/2019 had advertised 110 vacancies (UR-55, OBC-31, SC-16, ST-08 including PH(OH)-04, PH(VH)-01) for the Post of Welfare Officer/Probation Officer/Prison Welfare Officer under post code 14/19 in Social Welfare Department, GNCTD. The Board had conducted Tier-I (T) written examination on 24/11/2019 in offline mode.
2. DSSSB vide Result Notice No. 968 dated 06.03.2020 has provisionally selected 103 candidates for the post of Welfare Officer/Probation Officer/Prison Welfare Officer under post code 14/19 in Social Welfare Department, GNCTD.
3. The candidate having Roll No. 4500003249 of SC Category was selected in UR category as per merit. Further inadvertently the same candidate was also selected in SC category. Since candidate has already been selected in UR category as per merit, hence selection of the said candidate is hereby rescinded in SC category.
4. Further candidature of 07 candidates having Roll No. 4500003517 and 4500004364 in UR category, Roll Nos. 4500003646, 4500003742 & 4500003769 in OBC category, Roll Nos. 4500005084 in SC category & Roll No. 4500000095 in PH(OH)OL category were kept pending vide Result Notice No. 968 dated 06.03.2020. Now in view of additional documents furnished by these candidates whose candidature was kept pending for required documents, after preliminary scrutiny of the candidature of the candidate as per the provisions of the statutory Recruitment Rules and terms and conditions of the advertisement, the following candidates are hereby provisionally nominated as per their merit:

5. The candidature of 01 OBC candidate having Roll No **4500003742** is rejected in OBC category as the candidate is not eligible to seek the reservation benefits under OBC category in Delhi being OBC outsider.
6. The candidature of the following 02 candidates (OBC-02) has been kept still pending since candidates have not uploaded requisite documents in the e-dossier during the stipulated time period between 16.03.2020 to 25.03.2020, accordingly, their candidature kept pending due to reasons mentioned below in the remarks column:-

1	4500003646	The candidate is directed to upload documents related to departmental candidate since candidate has claimed age relaxation in this category.

7. The above pending 02 candidates (OBC-02) are being given 2nd and final opportunity to upload their pending/all requisite/applicable documents through the e-dossier link on OARS module of the Board within stipulated time. The e-dossier link shall be active from 07.08.2020 to 11.08.2020, failing which their candidature will be rejected and no further opportunity will be given on whatsoever ground. The above candidates are also being separately informed through SMS on their registered mobile number.
8. The selection of the above 06 candidates (UR-02, OBC-01, SC-02, PH(OH)OL-01) shall be further subject to thorough verification of the candidature of the candidate by the User Department including the identity of the candidate.
9. The Selection of the above 06 candidates (UR-02, OBC-01, SC-02, PH(OH)OL-01) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

10. The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Social Welfare Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
11. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
12. The User Department shall also get the SC/ST/OBC certificates verified from the issuing authority before his /her appointment. Further, in case of OBC Candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No. 36033/3/2004-Estt. (Res) dated 14/10/2008 and OM No. 36033/1/2013-Estt. (Res) dated 27/05/2013 & 13.05.2017.
13. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
14. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
15. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.



16. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
17. The result is subject to the outcome of the court cases, if any, pending in various courts related to this post.
18. The category wise marks scored by the last candidate provisionally nominated are as under:-
