- 1. In continuation of result notice No. 389 dated 11.05.2016 and subsequent result notice Nos. 460 dated 15.12.2016, 497 dated 31.03.2017, 538 dated 13.09.2017, 557 dated 12.10.2017, 611 dated 15.03.2018 and 612 dated 16.03.2018, while declaring the result of above post code, the result of candidates having roll no. 20019523 and 20006091, were kept pending under OBC Category due to complaints received against them.
- 2. That the Board had taken a decision to investigate the complaints and accordingly, candidates were called for giving writing sample, signatures, left and right thumb impressions.
- 3. The candidate having roll no. 20019523 appeared and given writing sample, signatures, left and right thumb impressions and the same were forwarded to FSL Department, GNCTD for authentication of genuineness of his candidature by comparing his signature & writing obtained in sample from OMR Sheet (Written Test) & Attendance Sheet (Skill Test).
- 4. The candidate having roll no. 20006091 did not appear despite of sufficient opportunities given to candidate for submitting writing sample, signatures, left and right thumb impressions. Accordingly, candidature of candidate having roll no. 20006091 is hereby rejected for the post of Gr. IV (DASS)/LDC under post code 68/12 in Services Department, GNCTD.
- 5. Based upon the documents/information submitted by the candidate having roll no. 20019523 and genuineness of the candidatures, the eligibility for the post have been verified as per the provisions of the RRs and terms and conditions of the advertisement and on the basis of report of FSL Department, GNCTD regarding genuineness of candidature of candidate, the candidate having following roll no. is provisionally selected to the post Gr. IV (DASS)/LDC under post code 68/12 in Services Department, GNCTD.

- 6. The selection of the above 01 candidate (OBC-01) shall be further subject to thorough verification of the candidature of the candidate by the User Department including the identity of the candidate.
- 7. The Selection of the above 01 candidate (OBC-01) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Services Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 10. The User Department shall also get the SC/ST/OBC certificates verified from the issuing authority before his /her appointment. Further, in case of OBC Candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No. 36033/3/2004-Estt. (Res) dated 14/10/2008 and OM No. 36033/1/2013-Estt. (Res) dated 27/05/2013 & 13.05.2017.

- 11. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
- 12. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 13. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
- 14. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
- 15. The result is subject to the outcome of the court cases, if any, pending in various courts related to this post.
- 16. The recruitment process for the Post of Grade-IV (DASS)/LDC under post code 68/12 in Services Department has already been closed. Further, the Wait List panel of the candidates has already been expired.
