SUPPLEMENTARY RESULT NOTICE No.: 1024 MATRON (Only for Female) (POST CODE- 63/2015) In Delhi Prison Department,

- 1. The DSSSB vide its advertisement number 01/15 with closing date 26/11/2015, had advertised 20 vacancies (UR-15, OBC-03, ST-02 including EXSM-07) for the Post of Matron in Delhi Prison Department under Post Code 63/15. The Board had conducted Physical Endurance Test (PET) for the applicants of the post code from 19/11/2018 to 30/11/2018 (except Sunday) at Sports Complex, East Vinod Nagar (Mayur Vihar Phase-II), Near Neelam Mata Mandir, Delhi-110091.
- 2. In the PET conducted, out of 6243 candidates only 539 candidates appeared for PET. Further from the 539 present candidates only 159 candidates could qualify the PET.
- 3. Vide notice no. 755 dated 04/01/2019, 158 candidates were declared qualified in PET and therefore were provisionally allowed to appear for written examination for post code 63/15, subject to correctness of the information furnished by the candidates in their online application forms. Out of these 158 candidates, 143 candidates appeared in written examination held on 29/03/2019.
- 4. DSSSB vide Result Notice No. 814 dated 27.08.2019 provisionally selected 13 candidates (UR-10, OBC-02, ST-01) for the post of Matron in Delhi Prison Department under Post Code 63/15.
- 5. User Department, i.e., Delhi Prison Department, Govt. of NCT of Delhi has returned 05 dossiers (UR-05) on the grounds that candidates have not responded/join/not found suitable to the post of Matron. The dossiers have been returned before the expiry of waitlist panel. Hence, the Board is declaring the Result of Panel/waitlisted candidates as per their merit.
- 6. After preliminary scrutiny of the Candidature of the candidates on the basis of documents uploaded/provided by them in their e-dossier as per the provisions of the statutory requirements rule for the post and the terms & conditions of the advertisement, the following candidates are provisionally selected to the post of Matron in Delhi Prison Department under Post Code 63/15.

- 7. The Candidates having roll no. 1101630155 who was earlier selected in OBC Category in this post code have now been shifted in UR Category as per their merit.
- 8. The selection of the above 05 candidates (UR-04, OBC-01) shall be further subject to thorough verification of the candidature of the candidate by the User Department including the identity of the candidate. Further, the User Department shall arrange measurement of physical standards, i.e. Height and Chest and also checking of defect or deformity (including bow-legged, Knocked Knees, Flat feet, etc.) of the candidates as per the requirements of the RRs, which has not been done by the DSSSB, before issues of appointment order.
- 9. The Selection of the above 05 candidates (UR-04, OBC-01) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough their identity with reference to their photographs, verification of signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- 10. The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Delhi Prison Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The

Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.

- 11. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 12. The User Department shall also get the SC/ST/OBC certificates verified from the issuing authority before his /her appointment. Further, in case of OBC Candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No. 36033/3/2004-Estt. (Res) dated 14/10/2008 and OM No. 36033/I/2013-Estt. (Res) dated 27/05/2013 & 13.05.2017.
- 13. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
- 14. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 15. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
- 16. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.

- 17. The result is subject to the outcome of the court cases, if any, pending in various courts related to this post.
- 18. The category wise marks scored by the last candidate provisionally nominated are as under:-
