DECLARATION OF TIER -II MARKS OF THE CANDIDATES FOR THE POST OF PGT (HINDI) UNDER POSTCODE 137/2012 AND CUTOFF MARKS FOR UPLOADING THE E-DOSSIERS

Board had shortlisted 779 candidates for appearing in Tier-II examination for the post of PGT (Hindi)(F) in Directorate of Education under postcode 137/2014 vide result notice number CC-I/394 dated 04.06.2015 and subsequent addendum notice No CC-I/403 dated 23.06.2015 and addendum notice No CC-I/409 dated 27.06.2015. The Tier-II examination for the post of PGT (Hindi) held on 28.06.2015 was cancelled vide Notice dated 30.07.2015. The said examination was again held on 26.06.2016, wherein 722 candidates appeared. Marks of the candidates have been uploaded on Board's website. The candidates can view their marks by logging into their account in OARS module on www.dsssbonline.nic.in.

2. Based on the performance in Tier-II examination held on 26.6.2016 163 candidates as detailed below have been provisionally allowed to upload e-dossiers in the ratio of 1:2 ratio subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms.

- 3. The ratio of 1:5 has been taken for provisionally shortlisting PH candidates, as their further category as OH or HH was not available in their online application form.
- 4. The Tier-II (objective) OMR sheet of the candidate having roll number 22008721 has not been evaluated.
- 5. The marks of the candidates having roll number 22007731, 22006222, 22007338, 22006404, 22005728 and 22006815 have been kept in sealed cover in pursuance of Ld CAT orders dated 23.6.15 in OA No

- 2178/15, dated 9.7.15 in OA no 2420/15, dated 23.6.15 in OA no 2225/15, dated 26.6.15 in OA no 2242/15 and dated 24.6.15 in OA no 2139/15.
- 6. The candidature of candidates having roll number 22003743, 22006585, and 22006169 who were provisionally allowed to appear in Tier-II examination in pursuance of court orders, is hereby rejected in view of Ld CAT order dated 23.7.16 in OA No.2240/15, dated 8.12.16 in OA No.2241/15 and dated 9.8.17 in OA No.2244/15.
- 7. In respect of candidates having roll number 22003532, 22006226, 22005851, 22004332 the verification of their candidature in postcode 137/12 is being undertaken, as they were initially provisionally allowed to appear in Tier-II examination by Ld CAT, and now their respective court cases have been disposed by Ld CAT with the direction to declare their result as per rules and procedure of the respondent. Similarly the candidature of the candidate having roll number 22004167 who was also provisionally allowed to appear in Tier-II examination is under verification.
- 8. The shortlisting of the candidate having roll number 22008713, who has been allowed to appear in Tier-II examination in pursuance to court order is purely provisional subject to verification of her candidature in postcode 137/12.
- 9. The candidature of candidate namely Arti to whom two separate roll numbers- 22008717 & 22004167 were issued is also pending for verification of her candidature in postcode 137/12.
- 10. Kindly note that the e-dossier link will be activated to only those candidates who are in the consideration zone of selection.
- 11. All the candidates who have been shortlisted for falling in the consideration zone of selection MUST provide their details and upload their requisite documents in the said link.
- 12. The e-dossier link shall be active from 10.10.2017 to 25.10.2017.
- 13. While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any stage.

- 14. In case of non-compliance of the above instructions regarding uploading the e-dossier, the candidature of the candidate is liable to be cancelled /rejected.
- 15. This issues with the prior approval of the Competent Authority.
