DECLARATION OF TIER -II MARKS OF THE CANDIDATES FOR THE POST OF
PGT (HINDI) UNDER POSTCODE 169/2014 AND
CUTOFF MARKS FOR UPLOADING THE E-DOSSIERS

Board had shortlisted 125 candidates for appearing in Tier-II examination for the post of PGT (Hindi) (M) in Directorate of Education under postcode 169/2014 vide result notice number CC-I/394 dated 04.06.2015 and subsequent addendum notice No CC-I/403 dated 23.06.2015 and addendum notice No CC-I/409 dated 27.06.2015. The Tier-II examination for the post of PGT (Hindi) held on 28.06.2015 was cancelled vide Notice dated 30.07.2015. The said examination was again held on 26.06.2016, wherein 109 candidates appeared. Marks of the candidates have been uploaded on Board's website. The candidates can view their marks by logging into their account in OARS module on www.dsssonline.nic.in.

2. Based on the performance in Tier-II examination held on 26.6.2016, **67 candidates** as detailed below have been provisionally allowed to upload e-dossiers in the ratio of 1:2 ratio subject to attaining minimum qualifying marks, and correctness of the information furnished by the candidates in their online application forms. The candidates who have been already considered in zone of selection in postcode 136/12 have not been included in the above ratio while calculating the number of candidates in zone of selection.

4. The candidature of candidate having roll number 22002408 who was provisionally allowed to appear in Tier -II examination in pursuance of court

order is hereby rejected in view of Ld CAT order dated 4.8.16 in OA No.3137/15.

5. In respect of candidate having roll number 22000007 verification of his candidature is being undertaken as he was provisionally allowed to appear in Tier-II examination.

6. The candidature of candidates namely Sunil Kumar to whom two separate roll numbers- 22001049 & 22002254, and Umeer Singh to whom also two separate roll numbers- 22000687 & 22001831 were issued is also being verified for postcode 169/14.

7. Kindly note that the e-dossier link will be activated to only those candidates who are in the consideration zone of selection.

8. All the candidates who have been shortlisted for falling in the consideration zone of selection MUST provide their details and upload their requisite documents in the said link.

9. The e-dossier link shall be active from 10.10.2017 to 25.10.2017.

10. While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any stage.

11. In case of non-compliance of the above instructions regarding uploading the e-dossier, the candidature of the candidate is liable to be cancelled /rejected.
