Based on the performance in examination, 28 candidates, as detailed below, have been provisionally allowed to upload e-dossiers in the ratio of 1:2 ratio (1: 3 where the number of vacancy is 01) subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms.
