- 1. The DSSSB vide its advertisement number 02/2014 with closing date 25/01/2015, had advertised 47 vacancies (UR-42, OBC-03, SC-01, ST-01 including 01 HH ExSM-05 and SP-02) for the Post of Stenographer, Grade-III in Services Department under Post Code 211/14 which were further increased to 349 vacancies (UR-173, OBC-100, SC-36, ST-40 including VH-07, HH-01, OH-04, ExSM-42 and SP-02) vide addendum dated 07/06/2018. Board Conducted Tier I Written Examination for selection to the Post along with similar Post Codes on 11/06/2017. Board had declared marks of Tier I written examination of the Candidates of the Post of Stenographer, Grade-III in Services Department under Post 211/14 vide notice number 550 dated 06/10/2017.
- 2. Based on the performance in the One Tier Examination, 666 candidates were shortlisted for appearing in the Phase II of shorthand and typewriting skill test vide notice no. 708 dated 25/08/2018 and 751 dated 13/12/2018. The Skill test for shorthand and typewriting was conducted with effect from 04/01/2019 to 06/01/2019, wherein 489 candidates have appeared. The result status of these candidates are being uploaded in OARS module, concerned candidate can check their status by logging into their account in OARS modules on www.dsssbonline.nic.in.
- 3. The Board has adopted the criteria for evaluation of skill test and in the skill test considered up to 7% mistake for UR category and up to 10% mistake for all reserved category candidates, on the pattern of SSC, as qualified in the shorthand skill test with a speed of 80 w.p.m.
- 4. As per RRs for the Post the candidate was to qualify the 40 w.p.m. in typewriting in English or 35 w.p.m. in typewriting in Hindi.
- 5. On the basis of above parameters out of 489 candidates who appeared for Phase-II Shorthand Skill test and Typewriting skill test, only 77 candidates have qualified the both Shorthand Skill Test and Typewriting skill test.
- 6. Based on the qualifying both Shorthand skill test and typewriting skill test following 77 candidates having roll numbers are provisionally allowed to upload e-dossiers—subject to correctness of the information furnished by the candidates in their online application form.

- 13. In case of non-compliance of the above instructions regarding uploading the e-dossier, the candidature of the candidate is liable to be cancelled/rejected.
