ORDER

This order shall dispose of the representation/grievance dated 21.05.2021, 24.05.2021, 26.05.2021, 28.05.2021, 31.05.2021, 04.06.2021 sent through email to the Secretary, DSSSB by Ms. Neetu Kumari (Roll No. 11241500035) candidate for the post of Assistant Teacher (Nursery), Post Code-16/19.

- 2. The candidate Ms. Neetu Kumari (Roll No. 11241500035) applied for the post of Assistant Teacher (Nursery) under Post Code-16/19 under OBC category and appeared in the computer based online examination on 19.11.2019 and scored 93.36 marks out of 200 marks. The Candidate was shortlisted for uploading of all the relevant documents in the edossier with regard to <a href="Educational/Professional Certificates/Degree and Mark sheets/Caste Certificate/Disability certificate/Proof of Govt. Servant/Ex. Servicemen/Admit Cards etc., as applicable in the E-dossier module in OARS link in his/her individual account in OARS module w.e.f. 30.06.2020 to 14.07.2020 (15 days) vide Notice No. F. No. 236/Result/Asstt. Teacher(Nursery)/Int. Cell/DSSSB/2019-20/1636-44 dated 22/06/2020 on the Board's website i.e. www.dsssb.delhi.gov.in.
- 3. That on scrutiny of the documents uploaded in the e-dossier by Ms. Neetu Kumari (Roll No. 11241500035), it has been found that the candidate has uploaded Diploma in Elementary Education & OBC certificate for applying for appointment to the posts under the Government of India whereas (i) Two years diploma in Nursery Teacher Training or B.Ed. (Nursery) from a recognized Institute was required as per RRs. Further, OBC (Delhi) certificate was required for taking benefit of OBC category. As the candidate has mentioned in OARS application form that she has done Diploma in Nursery from SCERT in September, 2016 with 72.21% marks, she was given 10 days first opportunity w.e.f. 25.11.2020 to 04.12.2020 to upload "Two years Diploma in Nursery Teacher Education programme or B.Ed. (Nursery) from a recognized Institute" & OBC (Delhi) certificate in the e-dossier vide notice dated 19.11.2020 duly published in the website of the Board.
- 4. That even after giving 10 days 1st opportunity w.e.f. 25.11.2020 to 04.12.2020, it was found that Ms. Neetu Kumari (Roll No. 11241500035) failed to upload the deficient / requisite documents in the e-dossier. Accordingly, she was given 05 days, 2nd and final opportunity w.e.f. 22.03.2021 to 26.03.2021 to upload (i) "Two years Diploma in Nursery Teacher Education programme or B.Ed. (Nursery) from a recognized Institute" & (ii) OBC (Delhi) certificate vide Notice No. F. No. 236/Result/Asstt. Teacher (Nursery)/Int. Cell/ DSSSB/

2019-20/708-716 dated 17/03/2021. The candidate has again failed to upload the above requisite documents in the e-dossier even after giving two opportunities though she uploaded other related documents in e-dossier. Hence, the candidature of the candidate Ms. Neetu Kumari (Roll No. 11241500035) has been rejected vide Rejection notice No. 806 dated 16.08.2021.

- 5. That the candidate Ms. Neetu Kumari (Roll No. 11241500035) has submitted representations dated 21.05.2021, 24.05.2021, 26.05.2021, 28.05.2021, 31.05.2021, 04.06.2021 stating that "I am Neetu Kumari sir maine DSSSB post code-16/19 assistant teacher nursery ka exam clear kiya tha. Jiski e-dossier link 22.03.2021 to 26.03.2021 tak k liye open hui thi. Usme maine 12th class ki mark sheet upload ki or update karte hi link close ho gai or m apna NTT ka diploma upload nahi kar pai".
- 6. That the above referred representation of the candidate has been examined in details and it is clear that her grievance/complaint is totally vague and baseless as the e-dossier link for uploading of documents for all the shortlisted candidates including Ms. Neetu Kumari was opened w.e.f. 30.06.2020 to 14.07.2020 and she had uploaded two years diploma in elementary education which is not applicable for the post of Assistant Teacher Nursery. Thereafter, she was given two more opportunities. First opportunity was given w.e.f. 25.11.2020 to 04.12.2020 & Second and final opportunity was given w.e.f. 22.03.2021 to 26.03.2021 but the candidate failed to upload the two years Diploma in Nursery or B.Ed. (Nursery) and accordingly, her candidature was rejected. Further, as the merit of UR category became lower and her candidature came in the zone of consideration under UR category, hence, OBC (Delhi) certificate was not required.
- 7. In view of the above, the above referred representations in r/o of Neetu Kumari (Roll No. 11241500035) has been considered and examined in details and dismissed as the reason for rejection of her candidature for the post of Assistant Teacher (Nursery), Post Code-16/19 is justified for not uploading documents related to two years diploma in Nursery or B.Ed. (Nursery) as required in RRs.
- 8. This issues with the approval of Competent Authority, DSSSB.
