## RESULT NOTICE NO- 134 LIBRARIAN (POST CODE NO 017/2007) DIRECTORATE OF EDUCATION, GOVT. OF NCT OF DELHI

As per merit of combined Part II (Descriptive) Examination held on 18.01.09 result of post code 17/07 nominating candidates to the posts of Librarian in the Directorate of Education in the pay scale of Rs. 5500-9000 (Pre revised) had been declared vide result notices dated 18-01.2010; 11.03.2010, 06.08.2010 and 08.11.2010 respectively.

In initial result process exercise, candidature of Ms. Barkha applicant in O.A. 1388/2010, was not considered for selection as her experience as Project Member w.e.f. August, 2005 to March, 2007 in M/S AIM Consultants Pvt. Limited, was not considered as a requisite experience for counting the total period of experience required for selection to the post of Librarian. Ms. Barkha has challenged the action of the Board before the Ld. CAT by filing OA No.1388/2010. Ld. CAT vide its order dated 19.10.2010 while allowing the OA has directed to deem the applicant eligible for the post and consider her claim for appointment as Librarian in the Directorate of Education.

In compliance of the order of Ld. CAT, on receipt of clarification from the Directorate of Education vide their letter No. 4/1/285/E-IV/2010/19029 dated 29.12.2010, result of Ms. Barkha as per particulars below is declared and she is provisionally selected to the post of Librarian in the Directorate of Education under post code 17/07:-

Further candidature of Ms. Seema too had not been considered for selection to the post in initial result process, as her Apprentice Training with National Medical Library w.e.f. 01.01.2003 to 31.12.2003 was not considered as a requisite experience for counting the total period of experience, for the post of Librarian. With reference to representation of Ms. Seema, the Directorate of Education vide their letter No.DE.4 (9) (5) Vol-IV/E-IV/08/405 dated 12-01-2011 has certified eligibility for the post with regard the requisite experience accordingly result of Ms. Seema as per particulars below is declared and she is provisionally selected to the post of Librarian in the Directorate of Education under post code 17/07:-

Mere inclusion of name in the result notice does not confer any right upon the candidate over the post. The selection shall also be subject to out come of pending litigations.
