- 1. This is in continuation of Result notice nos. 968 dated 31.12.2019 and 1102 dated 29.06.2020.
- 2. The DSSSB, vide its advertisement No. 02/17 had advertised 140 vacancy (UR-73, OBC-37, SC-20, ST-10 including EXSM 14) for the post of Patwari (Male) under Post Code-13/17 in Revenue Department, GNCTD.
- 3. Vide Notice no. 1102 dated 29.06.2020, candidature of the Seventeen (17) candidates (UR- 07, OBC-01, SC-02, ST-03, EXSM-04) was kept pending due to deficient documents required as per RRs. These 17 candidates, were directed to upload their deficient documents / all requisite / applicable documents etc., if any, through the e-dossier module and the e-dossier link was active from 03.07.2020 to 07.07.2020.
- **4.** The result has been processed keeping in view of the eligibility conditions and relaxation thereof in respect of educational qualifications etc. as on **cut off date i.e. 15.09.2017** for the post code-13/17.
- **5.** On the basis of marks secured in the written examination and after preliminary scrutiny, as per the provisions of the statutory Recruitment Rules for the post and the terms and conditions as stipulated in the advertisement, the following candidate is provisionally selected to the post of Patwari under Post Code-13/17 in Revenue Department, GNCTD subject to their fulfilling all other conditions of eligibility and also correctness of the information furnished by the candidates in their online application form and e-dossier:-

Note: Category of 01 candidate having roll No 12360100076 has been shifted from OBC to UR category due to lowering of merit of UR category who was earlier selected vide result notice no. 968 dated 31.12.2019.

*Note:- It is stated that the above candidates have uploaded different types of certificate/diploma/degree with regard to one of the essential qualifications i.e. One Year Diploma Course in Computer, however as per RRs one of the essential qualification is "One year Diploma Course in Computer from a Government recognized institution" Further, the same is a subjective and technical matter and User Department has not provided any specification in this regard. At this stage, DSSSB has not undertaken the



veracity/scrutiny of Computer certificate/Diploma furnished by the candidates. As such User Department i.e. Revenue Department, GNCTD is requested to ascertain the scrutiny/ correctness of the same at their own level before issuing the offer of appointment to the proposed candidates. The selection is provisional and subject to the satisfaction of User Department regarding Diploma/certificate furnished by above candidates.

7. Out of above 08 candidates, only the SIX (06) candidates, whose documents are deficient, are directed to upload their deficient documents / all requisite / applicable documents etc., if any, through the e-dossier

module in stipulated time. The e-dossier link shall be active **from 15.02.2021** to **24.02.2021** They are also being separately informed through SMS, as an additional facility, on their registered mobile number.

- 8. The provisionally selection of the above total Thirteen (13) candidates [UR-04, OBC-02, SC-01, ST-02 & EXSM-04 (UR-EXSM-03, OBC-EXSM-01)] shall be further subject to genuineness of the documents on the basis of which he has claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of his identity with reference to their photographs, signatures/ handwriting etc. on the application form, admission certificate etc. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules for the posts or for any other genuine reason. The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate.
- 9. The User department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms and e-dossier vis-à-vis the original documents. The user Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the The User Department is requested also candidate. rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 10. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidates in the light of Notification No. 36012/22/93-Esttt.(SCT)dated 08/09/1993 issued by DOPT and other instructions/ guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the user department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC(Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Deptt, GNCTD after thorough verification of caste certificate.
- 11. User Department shall also get the SC/ST/OBC certificates verified from the issuing authority. Further, in case of the OBC



- candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DOPT O.M. No. 36012/22/93-Estt.(SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14/10/2008 and 36033/1/2013-Estt. (Res) dated 27.05.2013.
- 12. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates including caste certificate as per Government of India instructions issued in this regard vide MHA OM No. 2/29/54-RPS, 19/11/54.
- 13. The User department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt issued from time to time.
- **14.** Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the user department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- 15. The recruitment process for the Post of Patwari under Post Code-13/17 in Revenue Department, GNCTD has already been closed subject to disposal of pending cases.
- 16. The Select panel/Waiting List for the Post of Patwari under Post Code-13/17 in Revenue Department, GNCTD has been maintained in respect of UR/OBC/SC/ST categories and the same was valid upto 30.12.2020. Further, the Select panel/Waiting list could not be maintained in respect of EXSM category as no suitable candidate was available in EXSM category.
- 17. The above result for the Post of Patwari under Post Code-13/17 in Revenue Department, GNCTD is subject to outcome of pending court cases, if any.
- **18.** The marks of last provisionally nominated/pending candidates in following categories, after this result, are as follows:-
