## ORDER

This order shall dispose of the representation/grievance dated 17.06.2021 filed by Ms. Nirmala (Roll No. 11141500491) candidate for the post of Assistant Teacher (Nursery), Post Code-16/19.

- 2. The candidate Ms. Nirmala (Roll No. 11141500491) applied for the post of Assistant Teacher (Nursery) under Post Code-16/19 under PH/OH category and appeared in the computer based online examination on 19.11.2019 and scored 77.21 marks out of 200 marks. The Candidate was shortlisted for uploading of all the relevant documents in the edossier with regard to <a href="Educational/Professional Certificates/Degree and Mark sheets/Caste">Educational/Professional Certificates/Degree and Mark sheets/Caste</a> Certificate/Disability certificate/Proof of Govt.   - 3. That on scrutiny of the documents uploaded in the e-dossier by Ms Nirmala (Roll No. 11141500491), it has been found that the candidate had not uploaded B. Ed (Nursery) or 2 years certificate /Diploma in Nursery Teacher Education Program required as per RRs. As the candidate has mentioned in OARS application form that she has done Diploma in Nursery from HBSE in April, 2016 with 76% marks, she was given 1st opportunity w.e.f. 11.06.2021 to 20.06.2021 to upload the two years diploma / certificate in Nursery Teacher Training Education program or B. Ed (Nursery) in the e-dossier vide notice No. F. 236/Result/Asstt. Teacher (Nursery)/Int. Cell/DSSSB/2019-20/1572-80 dated 10.06.2021 but she failed to upload the same. Hence, she was given 2nd and final opportunity w.e.f. 23.06.2021 to 27.06.2021 vide Notice No. F. 236/Result/Asstt. Teacher (Nursery)/Int. Cell/DSSSB/2019-20/1616-24 dated 22.06.2021 to upload the two years diploma / certificate in Nursery Teacher Training Education program or B.Ed (Nursery) in the e-dossier. But again she failed to upload the same.
    - 4. That even after giving two sufficient opportunities (1<sup>st</sup> opportunity w.e.f. 11.06.2021 to 20.06.2021 & 2<sup>nd</sup> and final opportunity w.e.f. 23.06.2021 to 27.06.2021), it was found that Ms. Nirmala (Roll No. 11141500491) failed to upload the deficient / requisite documents in the e-dossier. Hence, the candidature of the candidate Ms. Nirmala (Roll No. 11141500491) has been rejected vide Rejection notice No. 806 dated 16.08.2021.



- 5. That the candidate Ms. Nirmala (Roll No. 11141500491) has submitted representations dated 17.06.2021 which has been examined in detail and it is clear that her grievance/complaint is totally baseless as the e-dossier link for uploading of documents for all the shortlisted candidates including Ms. Nirmala (Roll No. 11141500491) was opened w.e.f. 30.06.2020 to 14.07.2020 and she did not upload two years diploma / certificate in Nursery Teacher Training Education program or B.Ed (Nursery) in the e-dossier but rest other documents were uploaded by her. Thereafter, she was given two more opportunities w.e.f. 11.06.2021 to 20.06.2021 & 23.06.2021 to 27.06.2021 but the candidate failed to upload two years diploma / certificate in Nursery Teacher Training Education program or B.Ed. (Nursery) in the e-dossier and accordingly, her candidature was rejected.
  - 6. In view of the above, the representations dated 17.06.2021 in r/o of Nirmala (Roll No. 11141500491) has been considered and examined in detailed and dismissed as the reason for rejection of her candidature for the post of Assistant Teacher (Nursery), Post Code-16/19 is justified as she failed to upload requisite documents as per RRs in the e-dossier.
  - 7. This issues with the approval of Competent Authority, DSSSB.
