NOTICE NO. 642 ASSISTANT (LEGAL), POST CODE 58/13, DELHI SC/ST/OBC/MINORITIES/HANDICAPPED FINANCIAL & DEVELOPMENT CORPORATION Ltd.

- 1. The DSSSB vide its advertisement No. 03/2013 had advertised 01 vacancy (UR-01) for the post of Assistant (Legal) under post code 58/13, in Delhi SC/ST/OBC/Minorities/Handicapped Financial Corporation & Development Corporation Ltd. with closing date 18.10.2013.
- 2. Board had conducted screening test/examination for the above said post on 26.04.2015 and on the basis of mark obtained in screening test/examination, result for shortlisting of candidates for appearing in Interview was also declared on 16.06.2016.
- 3. Later on, to follow the instructions of DoPT, GOI vide OM No. 39020/01/2013- Estt(B)-Part dated 29/12/2015. The Board (DSSSB) vide resolution no. P&P/2017/12 dated 25/05/2017 has decided to dispense with the interview from the selection process in respect of all posts. As such selection process in respect of posts having three tier examination scheme, whether already advertised with such scheme and/or posts where selection process is in mid-way, shall be converted into two-tier examination scheme with immediate effect and the final selection shall be made based on merit in Tier-II examination.
- 4. Further, vide notice dated 02.06.2017, Board had decided that all posts for which screening test had been conducted and it was to be followed by interview the screening test shall be disregarded/scrapped and selection shall be made as per the general scheme of exam prescribed for that post.
- 5. In view of discontinuation of interview stage and consequently scraping of screening test in r/o post code 58/13, Board had decided to conduct directly Tier-II combined Exam for post codes 58/13 alongwith 55/13 & 60/13. Therefore, a fresh Exam was notified vide notification dated 20.07.2017 and accordingly conducted on 13.08.2017 wherein 09 candidates appeared.
- 6. The marks obtained by 09 candidates who have appeared in written examination dated 13.08.2017 have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on www.dsssbonline.nic.in.
- 7. Based on the performance in the examination, candidates, as detailed below, have been provisionally allowed to upload e-dossiers subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms.

- 14.In case of non-compliance of the above instructions regarding uploading the e-dossier, the candidature of the candidate is liable to be cancelled / rejected.
