FOOT CONSTABLE (MALE) IN TRANSPORT DEPARTMENT, GNCTD. UNDER POST CODE- 44/13.

Attention is drawn to the Notice No. 779 dated 24.05.2019 vide which a total of 12964 candidates were provisionally selected on the basis of the Physical Standard Essential (PSE) conducted by the Board for Applicants for the Post of Foot Constable (Male) under Post Code 44/13 during 22.04.2019 to 05.05.2019 (14 days) at Chatrasal Stadium, Model Town, Ring Road, Delhi-110009 and Sports Complex, East Vinod Nagar (Mayur Vihar, Phase-II), Near Neelam Mata Mandir, Delhi-110091 to appear for Written examination. Attention is also drawn to the Result Notice No. 827 dated 26.09.2019 vide which the marks of 10736 candidates were declared who appeared for the Written examination held on 18.06.2019 & 27.06.2019 for the post of Foot Constable (Male) in Transport Department, GNCTD, Post Code- 44/13. Further, attention is also drawn to the Result Notice No. 867 dated 25.11.2019, No. 1044 dated 24.02.2020 & No. 1154 dated 04.08.2020, vide which Final results were declared for the post of Foot Constable (Male) in Transport Department, GNCTD, Post Code-44/13.

Attention is also drawn to the Order No. F.55(228)/EXAM/DSSSB/2021/11104 dated 10.09.2021, vide which the applicant namely Sh. Love Kumar Sharma S/o Tara Chand Sharma D.O.B.-12.08.1990 has been debarred from any examination conducted/to be conducted by the DSSSB for lifetime. The details are as under: -

Further, it is not out of place to mention here that the Candidates appearing in various examinations being conducted by the DSSSB have repeatedly been warned not to resort to any unfair means/ malpractices and further, that:-

"Any attempt to commit or abet, as the case may be all or any of the acts such as (i) Impersonating, and (ii) Procuring impersonation by any person, may in addition to render himself/herself liable to criminal prosecution, be liable:

- (a) To be disqualified by the Board from the examination for which he/ she is a candidate as also from any other examination/selection of the Board in which he/ she might have appeared by the final result/ selection has not been declared/ made and or
- (b) To be debarred either permanently or for a specified period from any examination held or selection made by them and or,
- (c) To take disciplinary action if he/she is already in service under Government and or, (d) To take any other legal action"
- Further, attention is drawn to the following provisions of the "General Instruction" for candidates for the various post Codes in online, offline & PET examination:-

"If any case of impersonation comes to notice then Overall In-charge & Observer shall lodge FIR against both persons i.e. candidates who applied and the impersonator under relevant sections. These persons shall also be debarred from appearing in future exams of DSSSB and other Board/ Commissions."

- 5. Thus, it is clear that the candidate had arranged to have another person taking examinations/PSE in place of him. Thus, the candidate and the impersonator have indulged in the following activities amounting to impersonation:
- (i) Appearing for examination for another candidate or arranging to have another person taken an examination for the candidate.
- ii) Allowing/Making somebody else to write answers on candidate's behalf during examination.
- iii) Helping or receiving help from other candidates to impersonate.
- iv) Signing/ getting signed the attendance sheet and other on somebody else's behalf either partially or completely.
- v) Providing admit card to another person to enable him to appear on behalf of the candidate.
- 6. Further, the candidate has also indulged in the act of **FORGERY** by altering the identity proof of candidate, admit card etc, and produced these documents to the examination/PSE conducting functionaries with the intent to defraud, as the documents produced are materially different from the records available with the DSSSB.
- 7. Therefore, it is evident that the candidate along with impersonator was actively involved in the crime related to impersonation, cheating, forgery, connivance and conspiracy as specified in Indian Penal Code.
- 8. In view of the above facts and circumstances, the DSSSB has come to the conclusion that, prima facie, a case of impersonation, cheating, forgery, connivance and conspiracy is made out against the candidate.
- MISCONDUCT by any candidate or any persons. Therefore, in view of the above facts and circumstances, the candidature of Sh. Love kumar Sharma S/o Sh. Tara Chand Sharma R/o VPO-Mahu Ibrahimpur ,The-Hindon city Distt-karoli/Netra Jyoti Hospital 70 Panchwati Near SMD Circle Scheme No-07, Alwar having Date of Birth: 12.08.1990 bearing Roll No.: 11170300246 (Written Examination) & Roll No. 2920014754 (PSE) of Post Code 44/13 is hereby cancelled and the provisional selection/short listing for the Written examination vide Result Notice No. 779 dated 24.05.2019 (Roll No. 2920014754) and the provisional selection made vide Result Notice No. 867 dated 25.11.2019 (Roll No. 11170300246) of Sh. Love Kumar Sharma S/o Sh. Tara Chand Sharma having Date of Birth: 12.08.1990, Pertaining to Post Code 44/13 is hereby rescinded.
