Final selection will be made purely on the basis of merit against the notified vacancies, provided the candidate falling in the zone of consideration, fulfils all the required eligibility conditions. It is stated that if a candidate fails to upload the deficient documents during the stipulated time, he will not be given any further opportunity for uploading the deficient documents on whatsoever ground and his candidature will be treated as rejected being ineligible.
