Subject:- Declaration of Marks of examination held on 30/07/2017 for the post of Assistant Engineer (E&M) in DJB, Post Code-10/12 and uploading e-dossier – regarding.

The DSSSB conducted two Tier common examination on 30.07.2017 for the post of Assistant Engineer (E&M) in Delhi Jal Board, Post Code-10/12. The marks statement (Tier-II Objective Type & Subjective Type) of the above Post Code has been uploaded on the Board's website for information of the candidates.

Further, as per scheme of examination dated 09.06.2017, the merit of the candidates has been prepared by giving 80% weightage of the marks scored in Part-I (Objective) paper & 20% weightage of the marks scored in Part-II (Descriptive) paper. All the qualified candidates based on the total weightage in both descriptive and objective papers have been shortlisted for uploading e-dossier.


The shortlisted candidates for the above mentioned post code are hereby informed to fill the e-dossier and upload all the documents of Educational/Professional Certificates/Degree and Mark sheets/Experience certificate/Disability Certificate/Caste Certificate/Proof of Govt. Servant/Ex. Servicemen/Admit Cards etc., as applicable in the E-dossier module in OARS link.

The link for uploading e-dossier shall be kept open for a period of 15 days w.e.f. **10/04/2018 to 24/04/2018**. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria as on the cutoff date, i.e., **15.06.2012** for Post Code-10/12. The shortlisted candidates are also being separately informed through SMS & E-Mail on their registered mobile number & e-mail id. **The candidature of the candidates who fail to upload the e-dossier during the above said period will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground.**

Mere asking the candidates for uploading documents in the e-dossier module does not confer them any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that the candidates who fail to upload their documents on or before the date as mentioned above will not be given any further opportunity and their candidature will be treated as cancelled.

Note: OBC (outsider) candidates have been treated as UR candidates.
