## ORDER No. 1294 LOWER DIVISION CLERK (POST CODE-51/13) IN MUNICIPAL CORPORATION OF DELHI

- 1. It is stated that all candidates who appeared in the Skill Test held on 26th February, 2021, 1st, 2nd, 3rd, 4th, 5th, 8th, 9th, 10th, 12th, 15th, 16th, 17th and 25th March, 2021 for the post of Lower Division clerk in Municipal Corporation of Delhi under Post Code 51/13 were given clear instructions through General Instructions to candidates for Skill Test (Shorthand/Typing) for the various post codes of various Department of GNCT of Delhi issued vide F.55(1474)/Exam/DSSSB/2019/2571 and 2572 dated 20/11/2019 including the following specific directions:-
- "26. Candidates who are seeking exemption from passing of typing test are directed to refer the guidelines laid down by DoPT, Govt. of India F.NO. 14020/2014-Estt. (D) dated 22nd April, 2015 for the Physically Handicapped persons/candidates who are seeking exemption from passing typing test which may be read as under:
  - a. Physically handicapped persons who are otherwise Qualified to hold clerical post and who are satisfied as being unable to type by the Medical Board attached to Special Employment Exchanges for the Handicapped (or by a Civil Surgeon where there is no such Board) may be exempted from passing the typing test.
  - b. The term 'physically handicapped persons' does not cover those who are visually handicapped or who are hearing handicapped but cover only those whose physical disability permanently prevent them from typing test

In view of the above, <u>candidates</u> who are seeking exemption are required to give <u>Certificate from Medical Board attached to Special Employment Exchanges for the handicapped (or by a Civil Surgeon where there is no such Board) that he/she is unable to type at Skill Test Centre on the date mentioned on e-Admit Card.</u>

- 27. The decision of the Board in all matters relating to eligibility, acceptance or rejection of the applications, penalty for false information, mode of selection, conduct of examination(s) and allotment of examination centres, selection and allotment of posts/organizations to selected candidates will be final and binding on the candidates and no enquiry/correspondence will be entertained in this regard.
- 28. The Board reserves the right to reject the candidature of any ineligible candidate at any stage of recruitment. Further, candidature of every candidate is purely provisional, at every stage until he is offered appointment by the concerned Department to which the post belongs, after due verification of documents and eligibility in respect of the post."
- 2. Whereas, vide notice no. **1180 dated 28/06/2021** the candidate having Roll No. 5200001312 was provisionally allowed exemption from passing the typing test under post code 51/13. The certificate submitted by the candidate has been examined by the Board in light of DoPT, Govt. of India F.NO. 14020/2014-Estt. (D) dated 22nd April, 2015 and General

instructions to the candidates for skill test issued by the Board dated 20/11/2019 and was not found "fit case" for allowing exemption as per requirement of para 2(ii)(a) of DoPT Office Memorandum dated 22nd April, 2015 and General Instructions to the candidates for skill test issued by the Board dated 20/11/2019, therefore he has not been allowed exemption from passing the typing test as per details mentioned in below table. The candidates failed to submit the certificate "as being unable to type" by the Medical Board attached to Special Employment Exchanges for the Handicapped (or by a Civil Surgeon where there is no such Board) at the examination centre on the date of typing test as mentioned against their name in below given table.
