ACCOUNTANT IN DELHI TRANSPORT CORPORATION UNDER POST CODE 24/2015

The DSSSB vide its advertisement number 01/2015 with closing date 26/11/2015, had advertised 05 vacancies (UR-04, OBC-01 including VH-01) for the post of Accountant in Delhi Transport Corporation under Post code 24/2015. Board has conducted combined One Tier Examination (T) for recruitment to this post on 30.07.2017. In the combined examination 362 candidates appeared for postcode 24/2015.

- 2. Marks of 356 candidates whose OMR sheet have been evaluated have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on www.dsssbonline.nic.in. The OMR of candidates having roll number 14901623, 14901636, 14901823, 14902067, 14902109 & 14901219 have not been evaluated as they have not correctly bubbled their roll number in the relevant space/column, accordingly their candidature is hereby cancelled.
- 2. Based on the performance in the examination, 17 candidates having roll number 14900827, 14901258, 14901293, 14901411, 14901671, 14901755, 14901918, 14902053 14902150, 14902289, 14902379, 14902718 in UR category; 14900877, 14902339, 14902763 in OBC category and 14900024, 14900070 in VH category have been provisionally allowed to upload e-dossiers in the ratio of 1:3 of the advertised vacancies, subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms.
