The DSSSB vide its advertisement number 01/2015 with closing date 26/11/2015, had advertised 41 vacancies (UR-22, OBC-10, SC-06, ST-03 including HH-01, OH-01) for the post of Assistant Foreman in Delhi Transport Corporation under Post code 18/2015. Board has conducted One Tier Examination (T) for recruitment to this post on 15.10.2017 wherein 199 candidates appeared.

2. Marks of 198 candidates who have appeared in written examination and whose OMR sheet were evaluated, have been uploaded on Board's website. Candidature of candidate having roll number 17200762 was not evaluated as he has not bubbled his roll number in the relevant space/column, accordingly his candidature is hereby cancelled.

Based on the performance in the examination, 26 candidates, as detailed below, have been provisionally allowed to upload e-dossiers who have attained marks above minimum qualifying marks, which are less than even the advertised vacancies, subject to correctness of the information furnished by the candidates in their online application forms.
