COMMUNITY WORKER IN MUNICIPAL CORPORATIONS OF DELHI UNDER POST CODE 60/2012

The DSSSB vide its advertisement No 02/2012 with closing date 15/06/2012, had advertised 55 vacancies (UR-30, OBC-16, SC-09) for the post of Community Worker in Municipal Corporations of Delhi under Post code 60/2012. Board has conducted One Tier Examination (G) for recruitment to this post on 21.05.2017 wherein 93 candidates appeared.

- 2. Marks of 92 candidates who have appeared in written examination have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on www.dsssbonline.nic.in. OMR of candidate having roll number 13900099 was not evaluated as candidate has not correctly bubbled his roll number in the relevant space/column; accordingly his candidature is hereby cancelled
- 3. Based on the performance in the examination, 70 candidates, as detailed below, have been provisionally allowed to upload e-dossiers in the ratio of 1:2 of the advertised vacancies, subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms.

- 4. The candidates who are overage as on cutoff date in UR category has been considered in their respective category.
- 5. Further the candidature of the candidate having roll number 13900193 has not been considered in UR category being overage as on cutoff date. As per the information furnished by the candidate in OARS, he does not belong to OBC(Delhi), accordingly he has also not been considered in OBC category.
