DEPUTY MANAGER (PERSONNEL) IN DELHI TRANSPORT CORPORATION UNDER POST CODE 26/2015

- 1. The DSSSB vide its advertisement Number 01/2015 with closing date 26/11/2015, had advertised 01 vacancy (UR-01 including PH-01) for the post of Deputy Manager (Personnel) in Delhi Transport Corporation under Post code 26/2015. Board has conducted Tier I Combined Examination for recruitment to this post on 15.10.2017, wherein 69 candidates have appeared in the examination for postcode 26/15 and 214/14.
- 2. Marks of 53 candidates of postcode 26/15 have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on www.dsssbonline.nic.in. Candidature of candidate having roll number 17100285 has not been evaluated as he has not correctly bubbled their roll number in the relevant space/column, accordingly his candidature is hereby cancelled.
- 2. Based on the performance in the Tier-I examination, 12 candidates have been provisionally allowed to appear in Tier II Examination for the postcode 26/15 in the ratio of 1:10 of the advertised vacancies, subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms.

Since documents have not been called from the candidates alongwith application forms as such detailed scrutiny regarding their eligibility has not been carried out, and therefore, mere inclusion of name in the list of candidate qualifying for appearing in Tier-II examination does not entitle him any right over the post.
