DEPUTY MANAGER (TRAFFIC) IN DELHI TRANSPORT CORPORATION UNDER POST CODE 214/2014

- 1. The DSSSB vide its advertisement No 02/2014 with closing date 25/01/2015, had advertised 03 vacancy (UR-02 & OBC-01) for the post of Deputy Manager (Traffic) in Delhi Transport Corporation under Post code 214/2014. Board has conducted Tier I Combined Examination for recruitment to this post on 15.10.2017 for postcode 26/15 and 214/14, wherein 69 candidates have appeared in the examination.
- 2. Marks of 14 candidates of postcode 214/14 whose OMR sheets have been evaluated have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on www.dsssbonline.nic.in. Candidature of candidate having roll number 17100340 has not been evaluated as he has not correctly bubbled his roll number in the relevant space/column, accordingly his candidature is hereby cancelled.
- 2. Based on the performance in the Tier-I examination 01 candidate having roll number 17100351 has been provisionally allowed to appear in Tier II Examination for the postcode 214/14 in the ratio of 1:6 of the advertised vacancies who had attained marks above the minimum qualifying marks i.e. 40% for UR and 35 % for OBC category, subject to correctness of the information furnished by the candidates in their online application forms.

3. The candidate who has been shortlisted for appearing in Tier – II examination for the post shall be called separately regarding the conduct of Tier – II examination.

- 4. Further the candidature of the candidate having roll number 17100386 has not been considered in UR category being overage as on cutoff date. As per the information furnished by the candidate in OARS, he does not belong to OBC(Delhi), accordingly he has also not been considered in OBC category.
- 5. Since documents have not been called from the candidate alongwith application forms as such detailed scrutiny regarding his eligibility has not been carried out and therefore mere inclusion of name in the list of candidate qualifying for appearing in Tier-II examination does not entitle him any right over the post.
- 6. While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any stage.
