1. The DSSSB vide its advertisement number 01/2015 with closing date 26/11/2015, had advertised 22 vacancies (UR-12, OBC-06, SC-03, ST-01 including OH-01) for the post of Draftsman (Civil) Grade III in New Delhi Municipal Council under Post code 32/2015. Board has conducted combined One Tier Examination (T) for recruitment to this post on 11.06.2017 for postcode 07/12 and 32/2015, wherein 208 candidates appeared under postcode 32/2015.

2. Marks of the 206 candidates who have appeared in written examination and whose OMR sheet was evaluated have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on [www.dsssonline.nic.in](http://www.dsssonline.nic.in). OMRs of candidates having roll number 14400297 and 14400654 were not evaluated as they had not bubbled their roll number in the relevant space/column; accordingly their candidature is hereby cancelled.

3. Based on the performance in the examination, 23 candidates having roll number- **14400005, 14400115, 14400136, 14400484, 14400521, 14400547, 14400689, 14400727 & 14400734** in UR category; **14400244, 14400453, 14400560, 14400671, 14400725 & 14400730** in OBC category; **14400184, 14400206, 14400260, 14400316 & 14400732** in SC category; **14400163, 14400317 & 14400733** in ST category have been provisionally allowed to upload e-dossiers in the ratio of 1:3 of the advertised vacancies subject to attaining one tier examination marks above minimum qualifying marks, subject to correctness of the information furnished by the candidates in their online application forms.

6. The e-dossier link shall be active from 23.04.2018 to 07.05.2018.
7. While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any stage.

As the Board has conducted combined examination for postcode 07/12 for the post of Draftsman Grade III in MCD and 32/15 for the post of Draftsman (Civil) Grade III in NDMC, therefore the candidates in zone of selection may furnish their preference of postcode at the time of uploading their documents in e-dossier.
9. In case of non-compliance of the above instructions regarding uploading the e-dossier, the candidature of the candidate is liable to be cancelled /rejected.
