1. The DSSSB vide its advertisement number 02/2012 with closing date 15/06/2012, had advertised 08 vacancies (UR-02, OBC-06 including OH/HH-01, EXSM-01) for the post of Draftsman Grade III in Municipal Corporations of Delhi under Post code 07/2012. Board has conducted combined One Tier Examination (T) for recruitment to this post on 11.06.2017 for postcode 07/12 and 32/2015, wherein 39 candidates appeared under postcode 07/12.

2. Marks of all the 39 candidates who have appeared in written examination and whose OMR sheets were evaluated have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on [www.dsssonline.nic.in](http://www.dsssonline.nic.in).

3. Based on the performance in the examination, 12 candidates having roll number **14400030, 14400036, 14400059, 14400063, 14400064, 14400727, 14400733 & 14400734** in UR category; **14400028, 14400071, 14400725 & 14400730** in OBC category have been provisionally allowed to upload e-dossiers in the ratio of 1:3 of the advertised vacancies subject to attaining one tier examination marks above minimum qualifying marks, subject to correctness of the information furnished by the candidates in their online application forms.

10. In case of non-compliance of the above instructions regarding uploading the e-dossier, the candidature of the candidate is liable to be cancelled /rejected.
