1. The DSSSB vide its advertisement No. 01/2015 had advertised 26 vacancies (UR-13, OBC-07, SC-04 & ST-02 Including EXSM-03) for the post of Fireman (Band) under post code 56/15, in Delhi Fire Services with closing date 26.11.2015. One tier written examination was conducted on 14.05.2017 wherein 53 candidates appeared.
2. The marks obtained by 51 candidates who have appeared in written examination have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on [www.dssbonline.nic.in](http://www.dssbonline.nic.in).
3. OMRs of candidate having roll number 13500599 and 13500589 were not evaluated as candidates had not correctly bubbled their roll number in the relevant space/column; accordingly their candidature is hereby cancelled.
4. Based on the performance in the written examination, all 37 candidates who are above the minimum qualifying marks in respective category, have been provisionally allowed to appear in Physical Endurance Test for the postcode 56/15 subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms.
5. The written exam was conducted for total 200 marks and evaluation was done out of 196 marks i.e. after deleting four questions. Now, applying the principle of conversion "from 200 marks to 100 marks", in the instant case the same will be treated as conversion from "196 marks to 98 marks".
6. The marks of candidates, who appeared in the examination, are being declared after conversion of marks from 196 marks to 98 marks.
