## DRAFTSMAN GRADE II (CIVIL) IN MUNICIPAL CORPORATIONS OF DELHI UNDER POST CODE 08/2012

- 1. The DSSSB vide its advertisement number 02/2012 with closing date 15/06/2012, had advertised 10 Vacancies (UR-07, OBC-03) for the post of Draftsman Grade II (Civil) in Municipal Corporations of Delhi under Post code 08/2012. South Delhi Municipal Corporation vide their letter number HC-IV/Engg./HQ/SDMC/2012/ 208 dated 30.08.2012 and letter number HC-IV/Engg./HQ/SDMC/2013/ 867 dated 18.2.2013 has informed that due to abolition of certain posts of Draftsman consequent upon trifurcation of MCD in three separate bodies the vacancies for the post of Draftsman Grade-II have been reduced to **02** (02 (UR)). Accordingly Board vide corrigendum dated 09.04.2013 to the advertisement number 02/12 has modified the vacancies for the post of Draftsman Grade II to 02 from 10.
- 2. Board has conducted combined One Tier Examination (T) for recruitment to this post on 21.05.2017 for postcode 08/12 and 09/12, wherein 46 candidates appeared under postcode 08/12.
- 3. Marks of 43 candidates who have appeared in written examination and whose OMR sheet were evaluated, have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on www.dsssbonline.nic.in. Candidature of candidate having roll number 14000073, 14000012, and 14000035 were not evaluated as they have not bubbled their roll number properly in the relevant space/column, accordingly their candidature is hereby cancelled.
- 4. Based on the performance in the examination, 07 candidates having roll number 14000014, 14000027, 14000042, 14000045, 14000078, 14000094 & 14000095 in UR category as per revised vacancies have been provisionally allowed to upload e-dossiers in the ratio of 1:8 of the advertised vacancies subject to attaining one tier examination- T marks above minimum

qualifying marks, subject to correctness of the information furnished by the candidates in their online application forms.

- 5. Kindly note that the e-dossier link will be activated to only those candidates who are in the consideration zone of selection.
- 6. All the candidates who have been shortlisted for falling in the consideration zone of selection MUST upload their all requisite/applicable documents in the said link.
- 7. The e-dossier link shall be active from 12.06.2018 to 26.06.2018.
- 8. While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any stage.
- 9. As the Board has conducted combined examination for postcode 08/12 for the post of Draftsman Grade-II in MCD and 09/12 for the post of Draftsman Grade-I in MCD, on the basis of the designation first preference is given to the postcode 09/12 having designation Draftsman Grade-I and second preference be given to postcode 08/12 having designation Draftsman Grade-II.
- 10. In case of non-compliance of the above instructions regarding uploading the e-dossier, the candidature of the candidate is liable to be cancelled /rejected.
