- 1. Board had declared the result for the post of Medical Record Clerk in MCD under postcode 49/2012 vide result notice 575 dated 17.11.2017 thereby selecting 02 candidates and keeping the candidature of 02 candidates as pending.

Based on the performance in Tier-I examination held on 30.08.2015 and thereafter qualifying the typing skill test, 03 candidates having roll number 10943221, 10901553, 10946999 are provisionally allowed to upload e-dossiers subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms.
- 4. The candidate having roll number 10946905 who had qualified the typing skill test held on 09.04.2017 is also allowed to upload e-dossiers subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms.
- 5. Kindly note that the e-dossier link will be activated to only those candidates who are in the consideration zone of selection.
- 6. All the candidates who have been shortlisted for falling in the consideration zone of selection MUST provide their details and upload their requisite documents in the said link.
- 7. The e-dossier link shall be active from 20.06.2018 to 04.07.2018.
