- 1. Board had declared the result for the post of Clerical Assistant in NDMC under postcode 153/2014 vide result notice 577 dated 17.11.2017 thereby selecting 50 candidates and keeping the candidature of 06 candidates as pending.
- 2. For selecting the candidates against the unfilled vacancies PH(OH), 06 candidates were additionally shortlisted vide result notice number CC I/616 dated 23.3.2018. The skill test of these 06 candidates was conducted on 15.04.2018 wherein 02 candidates appeared, their skill test result has been uploaded in website the candidate can view the same by logging into their account in OARS module on www.dsssbonline.nic.in.
- 3. Based on the performance in Tier-I examination held on 30.08.2015 and thereafter qualifying the typing skill test, 02 candidates having roll number 10900873 and 10900554 are provisionally allowed to upload e-dossiers subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms.
- 4. Kindly note that the e-dossier link will be activated to only those candidates who are in the consideration zone of selection.
- 5. All the candidates who have been shortlisted for falling in the consideration zone of selection MUST provide their details and upload their requisite documents in the said link.
- 6. The e-dossier link shall be active from 20.06.2018 to 04.07.2018.
- 7. The other unfilled vacancies will be considered by the already available qualified candidates as per their merit.
