## DECLARATION OF SKILL TEST RESULT OF THE CANDIDATES FOR THE POST OF LDC UNDER POSTCODE 156/2014 IN MAIDS AND NOTICE FOR UPLOADING THE E-DOSSIERS

- 1. Board had declared the result for the post of LDC in MAIDS under postcode 156/2014 vide result notice 576 dated 17.11.2017 thereby selecting 04 candidates.
- 2. For selecting the candidates against the 10 unfilled vacancies, 36 candidates were additionally shortlisted vide result notice number CC I/615 dated 23.3.2018. The skill test of these 36 candidates was conducted on 15.04.2018 wherein 27 candidates appeared, their skill test result has been uploaded in website the candidate can view the same by logging into their account in OARS module on <a href="https://www.dsssbonline.nic.in">www.dsssbonline.nic.in</a>. The nine candidates having roll numbers 10945309, 10953505, 10953464, 10946990, 10941914, 10953746, 10948926, 10954880 and 10946905 had already qualified the skill test conducted on 9.4.2017 on being shortlisted in postcode 153/2014.
- 3. Based on the performance in Tier-I examination held on 30.08.2015 and thereafter qualifying the typing skill test, 12 candidates having roll number 10945309, 10953505, 10953464, 10946990, 10941914, 10953746, 10935711, 10948926, 10954880, 10920214, 10946905 and 10922615 are provisionally allowed to upload e-dossiers subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms.
- 4. Kindly note that the e-dossier link will be activated to only those candidates who are in the consideration zone of selection.
- 5. All the candidates who have been shortlisted for falling in the consideration zone of selection MUST provide their details and upload their requisite documents in the said link.
- 6. The e-dossier link shall be active from 20.06.2018 to 04.07.2018.
