Supplementary Result Notice No.- 1084 Welfare Officer, Post Code-55/15 In Social Welfare Department, Govt. of NCT of Delhi

- 1. The DSSSB vide its advertisement number 01/2015 with closing date 26/11/2015 had advertised 06 vacancies (UR-02, OBC-02, SC-01, ST-01) for the post of Welfare Officer in Social Welfare Department under post code 55/15 in the pay scale of Rs. 9300-34800/- having grade pay 4200/- (Pre-revised). Board has conducted One Tier Examination (G) for recruitment to this post code on 27/08/2017. Marks of 185 candidates who appeared in the examination and whose OMR sheets were evaluated, were uploaded on Board's Website vide notice no. 600 dated 07/02/2018.
- 2. The DSSSB vide result notice no. 622 dated 09/04/2018 had provisionally selected 4 candidates for the post of Welfare Officer in Social Welfare Department under post code 55/15. Further, vide Result Notice No. 763 dated 07/02/2019 the candidate having roll no. 16100781 was shifted from SC Category to UR Category and therefore a candidate having roll no. 16101171 had provisionally been selected in SC Category.
- 3. The candidature of candidate having roll number 16100644 was kept pending in OBC category vide result notice 622 dated 09/04/2018 and subsequent result notice no. 763 dated 07/02/2019 for verification of allegations leveled in the complaint received in the Board against the candidate.
- 4. The documents submitted by the candidate in his e-dossier, i.e., OBC Certificate and MSW Certificate and mark sheet of the candidate were examined by the Board by sending these documents to the respective issuing authorities.
- That the Executive Magistrate (Civil Lines) has informed that the OBC (Delhi) Certificate No. 9021002449 has been issued to the candidate having roll no. 16100644.
- That the Institute of Advanced Studies in Education (IASE), deemed to be University, 6. Gandhi Vidya Mandir, Sardarshahr, Churu, Rajasthan has verified Mark sheet and Provisional degree of the candidate having roll no. 16100644. It has also been informed by the IASE, deemed to be University that they have been granted the status of deemed to be university under section 3 of the UGC Act, 1956, by the Government of India, Ministry of Human Resource Development (MHRD) and University Grant Commission (UGC) in the year 2002. All the programmes/courses offered by the university under distance mode were granted ex-post-facto up to 2005 vide its letter dated 29/08/2007 and provisional recognition/approval by DEC vide letter dated 03/09/2007 for a period of one year w.e.f. the date of issue of this letter based on the recommendations made by the UGC-AICTE-DEC joint committee in its meeting held on 07/08/2007. Further, the Hon'ble High Court of Rajasthan, at Jodhpur in its ad-interim stay dated 15/09/2008 in the SC Civil Writ Petition No. 5372/2008, has permitted IASE, deemed to be university to give admission to the students in the courses which were already running from the year 2007-2008.



- 7. That the Distance Education Bureau, University Grant Commission, 35 Feroze Shah Road, New Delhi 110001 has informed to the Board that The Institute of Advanced Studies in Education (IASE), Sardarshahr, Rajasthan is a Deemed to be University, UGC has not granted its approval to the university to offer technical courses under ODL mode. As per available records the erstwhile "Distance Education Council" (DEC) had granted ex-post-facto "Institutional" recognition to it for the programmes offered by it through distance mode up to the academic year 2005. The provisional institutional recognition was also granted to it for the academic year 2007-08. No further recognition has been granted to it either by DEC or UGC to offer any programmes through distance mode.
- 8. That all documents/replies received by the Board from the candidate, UGC, IASE and Executive Magistrate (Civil Lines) are being forwarded to the User Department, i.e., Social Welfare Department with directions that The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information / documents as furnished in the application form and e-dossier vis-à-vis the original documents related to education qualification, age and other essential certificate as per instructions issued by Govt. of India vide MHA OM No. 2/29/54-RRs19-11-54.
- 9. On the basis of the merit list of One Tier Examination held on 27/08/2017 and after preliminary scrutiny of eligibility for the post of as per the provisions of statutory RRs of the post and the terms and conditions of the advertisement, the following candidate is provisionally selected/nominated to the post of Welfare Officer in Social Welfare Department under post code 55/15.

Remarks:-

The Candidate having roll no. 16100644 had passed 10th from Soni High School, Bahadurgarh, Rohtak, Haryana. OBC (Delhi) Certificate issued vide No. 9021002449 dated 18/11/2009 issued by Executive Magistrate, Sadar Bazar, Distt. North, Delhi.

- 11. The selection to the above one candidate shall be further subject to the thorough verification of the candidature of the candidate by the User Department including the identity of the candidate. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules for the post or any other genuine reason. The decision of the user department/ appointing authority regarding the eligibility of the candidate shall be the final and binding on the candidate.
- 12. The Competent Authority of the user department shall arrange to verify the correctness of the information/ documents as furnished in application forms vis-à-vis the original documents including the educational qualification. Further, the appointing authority shall verify these documents and satisfy itself about the authenticity of documents/ certificates before finally appointing the candidate.
- 13. Since, the essential qualification related for said post code is technical in nature therefore, at this stage DSSSB has not undertaken the veracity/ scrutiny of the

essential education qualification furnished by the candidate as such user department i.e. Social Welfare Department, GNCTD is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the proposed candidate as per nature of job, provision of RRs of the said post and requirement of the department. The selection is provisional and subject to satisfaction of user department regarding essential qualification furnish by above candidate.

- 14. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information / documents as furnished in the application form and e-dossier vis-à-vis the original documents related to education qualification, age and other essential certificate as per instructions issued by Govt. of India vide MHA OM No. 2/29/54-RRs19-11-54.
- 15. The Selection of the above 01 candidate (OBC-01) shall further be subject to genuineness of the documents on the basis of which he has claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of his identity with reference to his photographs, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidate is liable to be cancelled by the user department also, in case the candidates is found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- 16. The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Social Welfare Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidate. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 17. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidate is fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.



- 18. The User Department shall also get the OBC certificates verified from the issuing authority before his /her appointment. Further, in case of OBC Candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No. 36033/3/2004-Estt. (Res) dated 14/10/2008 and OM No. 36033/I/2013-Estt. (Res) dated 27/05/2013 and 13/05/2017.
- 19. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 20. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- 21. Further waitlist panel/panel for the post code 55/15 stands expired on 08/04/2019 i.e. after one year from the date of declaration of result on 09/04/2018.
- 22. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
- 23. The result is subject to the outcome of the court cases, if any, pending in various courts related to this post.
- 24. The category wise marks scored by the last candidate provisionally nominated are as under:-
