## NOTICE NO.: 1093. TEACHER (PRIMARY) IN MUNCIPAL CORPORATION DEPARTMENT UNDER POST CODE- 16/17 & 01/18

Attention is drawn to the Notice No 760 dated 01.02.2019 vide which the marks of 73488 candidates were declared who appeared for the Offline examination held on 30.09.2018, 13.10.2018, 14.10.2018 and 28.10.2018 for the post of Teacher (Primary) in MCD, Post Code-16/17 & 01/18. Attention is also drawn to the Result Notice No. 773 dated 28.03.2019, vide which results were declared for the post of Teacher (Primary) in MCD, Post Code- 16/17 & 01/18.

2. However, subsequently, on analysis of Second page of Admit Card while forwarding of e-dossier to the MCD it has been found that Sh. Ashish Chhikara whose details are mentioned in table below, was found indulging in unfair means, malpractices and criminal activity like Cheating, Impersonation, Forgery, Conspiracy etc. during the above said post code exam:-

3. Further, it is not out of place to mention here that the Candidates appearing in various examinations being conducted by the DSSSB have repeatedly been warned not to resort to any unfair means/ malpractices and further, that:-

"Any attempt to commit or abet, as the case may be all or any of the acts such as (i) Impersonating, and (ii) Procuring impersonation by any person, may in addition to render himself/herself liable to criminal prosecution, be liable:

- (a) To be disqualified by the Board from the examination for which he/she is a candidate as also from any other examination/selection of the Board in which he/ she might have appeared by the final result/ selection has not been declared/ made and or
- (b) To be debarred either permanently or for a specified period from any examination held or selection made by them and or,
- (c) To take disciplinary action if he/she is already in service under Government and or,
- (d) To take any other legal action"
- 4. Further, attention is drawn to the following provisions of the "General Instruction" for candidates for the various post Codes in online, offline & PET examination:-

- 5. Thus, it is clear that the candidate had arranged to have another person taking examinations in place of him. Thus, the candidate and the impersonator have indulged in the following activities amounting to impersonation:
  - i) Appearing for examination for another candidate or arranging to have another person taken an examination for the candidate.
  - ii) Allowing/Making somebody else to write answers on candidate's behalf during examination.
  - iii) Helping or receiving help from other candidates to impersonate.
  - iv) Signing/ getting signed the attendance sheet and other on somebody else's behalf either partially or completely.
  - v) Providing admit card to another person to enable him to appear on behalf of the candidate.
- 6. Further, the candidate has also indulged in the act of **FORGERY** by altering the identity proof of candidate, admit card etc, and produced these documents to the examination conducting functionaries with the intent to defraud, as the documents produced are materially different from the records available with the DSSSB.
- 7. Therefore, it is evident that the candidate along with impersonator was actively involved in the crime related to impersonation, cheating, forgery, connivance and conspiracy as specified in Indian Penal Code.
- 8. In view of the above facts and circumstances, the DSSSB has come to the conclusion that, prima facie, a case of impersonation, cheating, forgery, connivance and conspiracy is made out against the candidate.
- 9. The DSSSB adheres to ZERO TOLERANCE POLICY TOWARDS ANY MISCONDUCT by any candidate or any persons. Therefore, in view of the above facts and circumstances, the candidature of Sh. Ashish Chhikara S/o Parkash Chand, R/o H.No 340, VPO-Jaunti, Delhi-110081 having Date of Birth: 13/05/1993 bearing Roll No.: 2800059979 of Post Code 16/17 & 01/18 is hereby cancelled and the provisional selection made vide Result Notice No. 773 dated 28.03.2019 of Sh. Ashish Chhikara S/o Parkash Chand having Date of Birth: 13/05/1993 bearing Roll No.: 2800059979 of Post Code 16/17 & 01/18 is hereby rescinded.
