NOTICE NO. 1114 JUNIOR AUDITOR (LDC) (POST CODE 65/14) IN MUNICIPAL CORPORATION OF DELHI (MCDs)

- The DSSSB vide its Advertisement No. 01/2014 with closing date 27/02/2014 had advertised 24 vacancies (UR-14, OBC-6, SC-3, ST-1) for the post of Junior Auditor (LDC) in Municipal Corporation of Delhi (MCDs) under Post Code 65/14. Board Conducted Tier-I written examination for recruitment in respect of this post on 01/11/2019.
- 2. On qualifying Written Examination, vide Notice No. 878 dated 16/01/2020, the DSSSB has shortlisted 241 candidates for appearing in Skill Test/Typing Test for the post of Junior Auditor (LDC) under Post Code 65/14. The Skill Test was conducted on 19/02/2021 and 22/02/2021 wherein out of 241 candidates, 176 candidates appeared for the test. In the Skill Test conducted, out of 176 candidates only 132 candidates could qualify.
- 3. As per RRs for the Post the candidate was to qualify the 35 w.p.m. in typewriting in English or 30 w.p.m. in typewriting in Hindi.

5. Based on the performance in the written examination and being qualified in Skill Test, 62 candidates (UR-32, OBC-16, SC-10 and ST 04) out of 132 candidates who

have qualified the typewriting skill test in their respective category as per details given below are being provisionally shortlisted and accordingly allowed to up-load e-dossier subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application form.

- 6. The shortlisted candidates for the above-mentioned post/post code are hereby informed to fill the e-dossier and up-load all the documents of Educational Certificate/Professional/Experience Certificates/Degree and Marks sheets/Caste Certificate/Proof of Govt. Servant/Ex Servicemen/Admit Cards, etc., as applicable in the e-dossier module in OARS link in their individual accounts in OARS module. Short listing is being made on the basis of marks obtained in Tier-I examination (Objective-MCQ) for 200 marks and being also qualified in skill test.
- 7. Kindly note that the e-dossier link will be activated to only those candidates who are provisionally shortlisted to upload e-dossier as per details given in para 5 above.
- 8. All the candidates who have been shortlisted for falling in consideration zone of selection MUST upload their all requisite/applicable documents in the said link in stipulated time.
- 9. The e-dossier link shall be active from <u>24/03/2021 to 07/04/2021</u>. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria/all essential qualifications as per RRs for the Post as on date of Closing date of application, i.e., <u>27/02/2014</u>.
- 10. The above shortlisted candidates are also being separately informed through SMS and e-mail on their registered mobile number and e-mail ID <u>as an additional facility</u>. If any candidate fails to upload the e-dossier during their above said period, his/her candidature will be rejected and no further opportunity will be given on whatsoever ground.
- 11. All the candidates who have shortlisted for uploading e-dossiers MUST upload their all requisite/applicable documents in the said link in stipulated time i.e. 24/03/2021 to 07/04/2021.
- Mere asking the candidate for up-loading documents in the e-dossier module does not confer upon him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he/she will not be given any further opportunity and his candidature will be treated as cancelled.
