STENOGRAPHER, GRADE-III (POST CODE 21/18)
IN SERVICES DEPARTMENT, GNCT OF DELHI

1. The DSSSB vide its Advertisement No. 02/18 with closing date 13/08/2018 and subsequent corrigendum dated 19/07/2018, Addendum dated 07/09/2019 and corrigendum to addendum dated 10/12/2019 had advertised **256 vacancies (UR-91, OBC-101, SC-24, ST-40 including OH-05, HH-04, VH-09, Multiple Disability-01, EXSM-17 and SP-06)** for the post of STENOGRAPHER, GRADE-III in Services Department, GNCT Of Delhi under Post Code 21/18. Board Conducted Tier-I written examination for recruitment in respect of this post on 04/10/2019 and 10/10/2019.
2. On qualifying Written Examination, vide Notice No. **882 dated 23/01/2020**, the DSSSB has shortlisted 1947 candidates for appearing in Skill Test/Shorthand Test and Typing Test for the post of Stenographer, Grade-III under Post Code 21/18. The Skill Test was conducted on 9th, 10th, 11th, 12th, 15th, 16th, 17th, 18th, 19th, 22nd, 23rd, 24th, 25th, 26th, February, 2021 and 1st, 2nd, 3rd, 4th, 5th, 8th, 9th, 10th, 12th, 15th, 16th and on 25th (for VH) March, 2021 (Total 26 days) wherein out of 1947 candidates, 1294 candidates appeared for the test. In the Skill Test conducted, out of 1294 candidates only 425 candidates could qualify.
3. In evaluation of the shorthand skill test answer sheets of candidates, the Board has considered/condoned up to 7% mistakes for UR category candidates and up to 10% mistakes for all reserved category candidates, as qualified with a speed of 80 w.p.m.
4. Those reserved category candidates who were shortlisted in UR Category as per clause 7 of notice no. 882 dated 23/01/2020, for appearing in Skill Test, availing relaxation of mistakes/percentage of errors up to 10%, shall be considered in their respective category.
5. As per RR of the Post the candidate was to Qualify 40 w.p.m. in Typewriting in English or 35 w.p.m. in Typewriting in Hindi, as well.
6. The roll numbers of 425 candidates who have qualified both Shorthand skill test and Typewriting skill test separately and therefore considered qualified Skill Test under Post Code 21/18, are as under:-

Based on the performance in the written examination and being qualified in Skill Test of post code 21/18, all 425 candidates (UR-178, OBC-174, SC-46, ST-21, OH-02, VH-01, EXSM-01 and Sports-02) who have qualified both, the typewriting skill test as well as Shorthand Skill Test, in their respective category as per details given below

are being provisionally shortlisted and accordingly allowed to up-load e-dossier subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application form.

The shortlisted candidates for the above-mentioned post/post code are hereby informed to fill the e-dossier and up-load all the documents of Educational Certificate/Professional/Experience Certificates/Degree and Marks sheets/Caste Certificate/Proof of Govt. Servant/Ex Servicemen/Admit Cards, etc., as applicable in the e-dossier module in OARS link in their individual accounts in OARS module. Short listing is being made on the basis of marks obtained in Tier-I examination (Objective-MCQ) for 200 marks and being also qualified in skill test.
9. Kindly note that the e-dossier link will be activated to only those candidates who are provisionally shortlisted to upload e-dossier as per details given in para 7 above.
10. All the candidates who have been shortlisted for falling in consideration zone of selection **MUST** upload their all requisite/applicable documents in the said link in stipulated time.
11. The e-dossier link shall be active from 28/04/2021 to 12/05/2021. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria/all essential qualifications as per RRs for the Post as on date of Closing date of application, i.e., 13/08/2018.
12. The above shortlisted candidates are also being separately informed through SMS and e-mail on their registered mobile number and e-mail ID as an additional facility. If any candidate fails to upload the e-dossier during their above said period, his/her candidature will be rejected and no further opportunity will be given on whatsoever ground.
13. All the candidates who have shortlisted for uploading e-dossiers **MUST** upload their all requisite/applicable documents in the said link in stipulated time i.e., 28/04/2021 to 12/05/2021.
14. Mere asking the candidate for up-loading documents in the e-dossier module does not confer upon him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her

documents on or before the date as mentioned above he/she will not be given any further opportunity and his candidature will be treated as cancelled.

15. The above short listing of candidates for calling of e-dossier for the post code -21/18 will be subject to outcome of pending court cases, if any.
16. The short listing of candidates for calling of e-dossier for the post code -21/18 is subject to the outcome of OA No. 599/2021 and any other Court Cases pending in various courts related to this Post.
17. While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any later stage.
