TGT (ENGLISH) MALE, POST CODE-131/17 IN DIRECTORATE OF EDUCATION

In continuation of Rejection Notice No. 431 dated 07.05.2019, Rejection Notice no., 581 dated 15.01.2020, Rejection Notice No. 669 dated 23.09.2020 & Rejection Notice No. 734 dated 21.12.2020, on scrutiny of marks secured in the written examination and after preliminary scrutiny as per the provision of the statutory Recruitment Rules for the post of TGT (English) Male, Post Code-131/17 in Directorate of Education and the terms and conditions of the advertisement, the candidature of the candidates bearing roll nos. mentioned below is rejected for the reason mentioned against his roll no.

UR Category:-

Sl. No.	Roll No.	Reason
1	2650005781	Overage, As the candidate had applied under ExSM ctgy. but did not upload any relevant documents with regard to ExsM ctgy. Hence, he was given two opportunities to upload the relevant documents in the e-dossier but he failed to upload the same. Hence, rejected for being overage.
2	2650002120	The candidate had not uploaded CTET qualified certificate in the e-dossier. Therefore, his e-dossier was recalled by giving two opportunities w.e.f. 26.02.2021 to 07.03.2021 & 11.03.2021 to 15.03.2021 but he failed to upload CTET qualified certificate as on cutoff date. Hence, Rejected.
3	2650006430	The candidate had uploaded CTET qualified with 88 marks under relaxed standard, i.e. OBC category. He is OBC (Outsider) and accordingly, CTET qualified with relaxed standard cannot be considered under UR category. However, he has also uploaded CTET qualified certificate under UR category which is after cutoff date. Hence, rejected for having CTET after cutoff date.
4	2650002480	The candidate had uploaded CTET qualified in 2015 with 89 marks under relaxed standard, i.e. OBC category. He is OBC (Outsider) and accordingly, CTET qualified with relaxed standard cannot be considered under UR category. Therefore, his e-dossier was recalled by giving two opportunities w.e.f. 26.02.2021 to 07.03.2021 & 11.03.2021 to 15.03.2021 to upload the CTET qualified certificate without relaxed standard as on cutoff date, but he failed to upload the same. Hence, rejected.
