## REJECTION NOTICE NO. 1325 GRADE-II (DASS) (POST CODE 81/17) IN SERVICES DEPARTMENT

- 1. The DSSSB vide its Advertisement No. 03/17 with closing date 21/11/2017, addendum dated 09/07/2019 and corrigendum to addendum dated 20/03/2020 had advertised 266 vacancies (UR-135, OBC-78, SC-34, ST-19 including ExSM-48, Sport Person-11, OH-2, HH-07, VH-07) for the post of Grade-II (DASS) in Services Department under Post Code 81/17. Board Conducted Tier-I written examination for recruitment in respect of this post from 16/07/2019 to 19/07/2019 and 22/07/2019 to 25/07/2019. The online Tier II examination was held on 08/11/2019. The Exit Examination was held on 31/07/2021.
- On qualifying Tier-II Written Examination, vide Notice No. 1094 dated 23/12/2020, the DSSSB had shortlisted 429 candidates for appearing in Exit Examination for the post of Grade-II (DASS) under Post Code 81/17 as per notified Examination Scheme. The Exit Examination was conducted on 31st July, 2021, wherein out of 429 candidates, 389 candidates appeared for the test. In the Exit Examination conducted, out of 389 candidates present in the examination all 389 candidates qualified. Further, the candidate having roll no. 113208100155 (Tier III roll No.) was allowed to appear in Exit Examination on provisional basis in compliance of Court Order in OA No.1407/2021, in the matter of Yogesh V/s DSSSB. The participation of candidate in the Exit Examination having roll no. 113208100155 (Tier II roll no. 12321000998) shall be subject to outcome of OA No. 1407/2021.
- 3. Vide Notice No. 1094 dated 23/12/2020 it was informed that 42 candidates were short listed for appearing in Exit Examination on provisional basis and separate notice will be issued to these candidates, directing to upload their deficient documents, if required by the Board, on OARS module in their respective edossiers in stipulated time. Subsequently, vide Notice No. 1251 dated 12/10/2021, Notice No. 1303 dated 29/10/2021 and Notice No. 1308 dated 03/11/2021 deficient documents were called and obtained from candidates as per requirement of Board.
- 4. Whereas all candidates were instructed vide clause 7 (x) of the said advertisement that the educational qualification, age, experience, and other eligibility conditions against the post shall be determined as on the closing date of online submission of application.



- 5. Whereas all candidates were informed vide clause 5 (ii) of the said advertisement that Candidates who wished to be considered against reserved vacancies and/or to seek age relaxation, must be in possession of relevant certificates (SC/ST/OBC/Non Creamy layer/PH/Educational/Experience, etc.) issued by the competent/notified authority(in prescribed format) on or before the cutoff date (closing date of advertisement) otherwise their claim for any category will not be entertained and their applications will be considered against Un-reserved (UR) category vacancies, if eligible otherwise.
- Now, on scrutiny of the documents uploaded by the candidates in the e-dossier module, the candidates bearing following Roll No. in respect of the above mentioned post code has been found to be 'Not Eligible' in terms of the advertisement no. 03/2017 with closing date 21/11/2017 and Recruitment Rules for the post of Grade-II (DASS) under post code 81/17 in Services Department Govt. of NCT of Delhi. The candidature of the candidate is therefore, stands rejected:-

Since the candidate was short listed in OBC category for appearing in Tier-II Examination on the basis of marks obtained by him (Cut off for UR was 146.35 where as the candidate has obtained 133.78 marks out of 200) in Tier I Examination he cannot be considered in UR category in post code 81/17 at later stage.
