CANDIDATURE CANCELLATION NOTICE No.:- 1324
GRADE-II (DASS) (POST CODE 81/17)
IN SERVICES DEPARTMENT, GNCT OF DELHI

Attention is drawn to the Notice No. 824 dated 01/10/2019 vide which the Tier-I normalized marks of candidates were declared who appeared for the Online Examination held from 16/07/2019 to 19/07/2019 and 22/07/2019 to 25/07/2019 and candidates were shortlisted for appearing in Tier II Written Examination, Notice No. 1070 dated 12/10/2020 vide which the Tier II prorated marks of candidates were declared who appeared for the online examination held on 08/11/2019 and e-dossiers were called from all qualified candidates. The Tier II qualified candidates were informed to fill the e-dossier and up load all the requisite documents as per requirement of RR and as per requirement of their application form to the post of Grade-II (DASS) in Services Department under Post Code 81/17. Attention is also drawn to the Notice No. 1094 dated 23/12/2020 vide which 429 candidates were shortlisted for appearing in Exit Examination as per Examination Scheme for the Post of Grade-II (DASS) in Services Department under Post Code 81/17.

2. Attention is also drawn to the Board's Order No F. 55(299)/EXAM/DSSSB/2021/12187-97 dated 29/11/2021 vide which the Candidate VISHAL KUMAR SAROHA, having roll No. 12321001375 under post code 81/17, DOB: - 25/01/1993, S/o KRISHAN KUMAR SAROHA, RZ-N 71 NEW ROSHANPURA NAJAFGARH NEW DELHI has been debarred from any examination conducted/ to be conducted by DSSSB for life time w.e.f. 23/07/2019. Further, candidature of Sh. VISHAL KUMAR SAROHA will be deemed cancelled if he appeared in any examination conducted by the Board prior to above date.

3. That vide above-mentioned debarment order dated 29/11/2021 it has been found/conveyed to all that Sh. VISHAL KUMAR SAROHA whose details are mentioned in table below, was found indulging in unfair means, malpractices and criminal activities like Cheating, Impersonation, Forgery, Conspiracy, etc. during the above said post code exam:-

4. Further, it is not out of place to mention here that the Candidates appearing in various examinations being conducted by the DSSSB have repeatedly been warned not to resort to any unfair means/malpractices and further, that:

'Any attempt to commit or abet, as the case may be, all or any of the acts such as (i) Impersonating, and (ii) Procuring impersonation by any person, may in addition to rendering himself/herself liable to criminal prosecution, be liable:

- a) To be disqualified by the Board from the examination for which he/she is a candidate as also from any other examination/selection of the Board in which he/she might have appeared but the final result/selection has not been declared/made and or*
- b) To be debarred either permanently or for a specified period which may extend to 10 years by the Board from any examination held or selection made by them and or,*
- c) To take disciplinary action under appropriate rules if he/she is already in service under Government and or,*
- d) To take any other legal action.'*

5. Further, attention is drawn to the following provisions of the "General Instruction" for candidates for the various post codes in online, offline and PET/Skill Test examination.

"If any case of impersonation comes to notice then overall in-charge and observer shall lodge FIR against both persons, i.e., candidate who applied and the impersonator under relevant sections. These persons shall also be debarred from appearing in future exams of DSSSB and other Board/Commissions."

6. Thus it is clear that the candidate had arranged to have another person taking examination in place of him. Thus, the candidate and the impersonator have indulged in the following activities amounting to impersonation:

- i. Appearing in examination for another candidate or arranging to have another person take an examination for the candidate.
- ii. Allowing/Making somebody else to write answers on candidate's behalf during examination.
- iii. Helping or receiving help from other candidates/persons to impersonate.
- iv. Signing /getting signed the attendance sheet and other examination documents on somebody else's behalf either partially or completely.
- v. Providing admit card and Aadhar Card (with change of photo) to another person to enable him to appear on behalf of the candidate.

7. Further, the candidate has also indulged in the act of **FORGERY** by altering the identity proof of candidate, admit card etc. and produced these documents to the examination conducting functionaries with the intent to defraud, as the documents produced are materially different from the records available with the DSSSB.

8. Therefore, it is evident that the candidate along with impersonator was actively involved in the crime related to impersonation, cheating, forgery, connivance and conspiracy as specified in Indian Penal Code.

9. In view of the above facts and circumstances, the DSSSB has come to the conclusion that, prima facie, a case of impersonation, cheating, forgery, connivance and conspiracy is made out against the Candidate.

10. The DSSSB adheres to ZERO TOLERANCE POLICY TOWARDS ANY MISCONDUCT by any candidate or any persons. Therefore, in view of the above facts and circumstances, the

candidature of the candidate **Sh. VISHAL KUMAR SAROHA, S/o KRISHAN KUMAR SAROHA, RZ-N 71 NEW ROSHANPURA NAJAFGARH NEW DELHI, having Date of Birth 25/01/1993, bearing roll no. 12321001375 (Tier-II) of post code 81/17** is hereby cancelled.
